

NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO MONUMENT THE ADJUSTED LINE AND TO FILE FOR RECORD A PROPERTY LINE ADJUSTMENT BETWEEN LOT K, TOWN OF BELMONT AND THAT TRACT OF LAND DESCRIBED IN DEED RECORDED AS INSTRUMENT NO. 2000 1783. THE BOUNDARIES OF LOT K, TOWN OF BELMONT WERE ESTABLISHED BY PRORATION AS PER THE RESOLUTION OF CS 2005 101. TAX LOT 200 WAS CREATED BY LAND DIVISION AS DEPICTED BY CS 85087 AND CS 88046. THOSE SURVEYS USED THE ACCEPTED POSITION OF THE WEST QUARTER CORNER PRIOR TO ITS RELOCATION BY THE COUNTY SURVEYOR IN 1989. THIS SURVEY HOLDS CS 88046 TO ESTABLISH THE BOUNDARIES OF THOSE LINES CREATED BY THE LAND DIVISION. THIS SURVEY HOLDS THE RELOCATED POSITION OF THE WEST QUARTER CORNER IN ESTABLISHING THE EAST AND SOUTH LINES OF TAX LOT 200 WHICH WERE ON THE EXTERIOR BOUNDARY OF THE PARENT PARCEL. THE ADJUSTED LINE WAS FSTABLISHED AS PER CLIENT INSTRUCTION.
