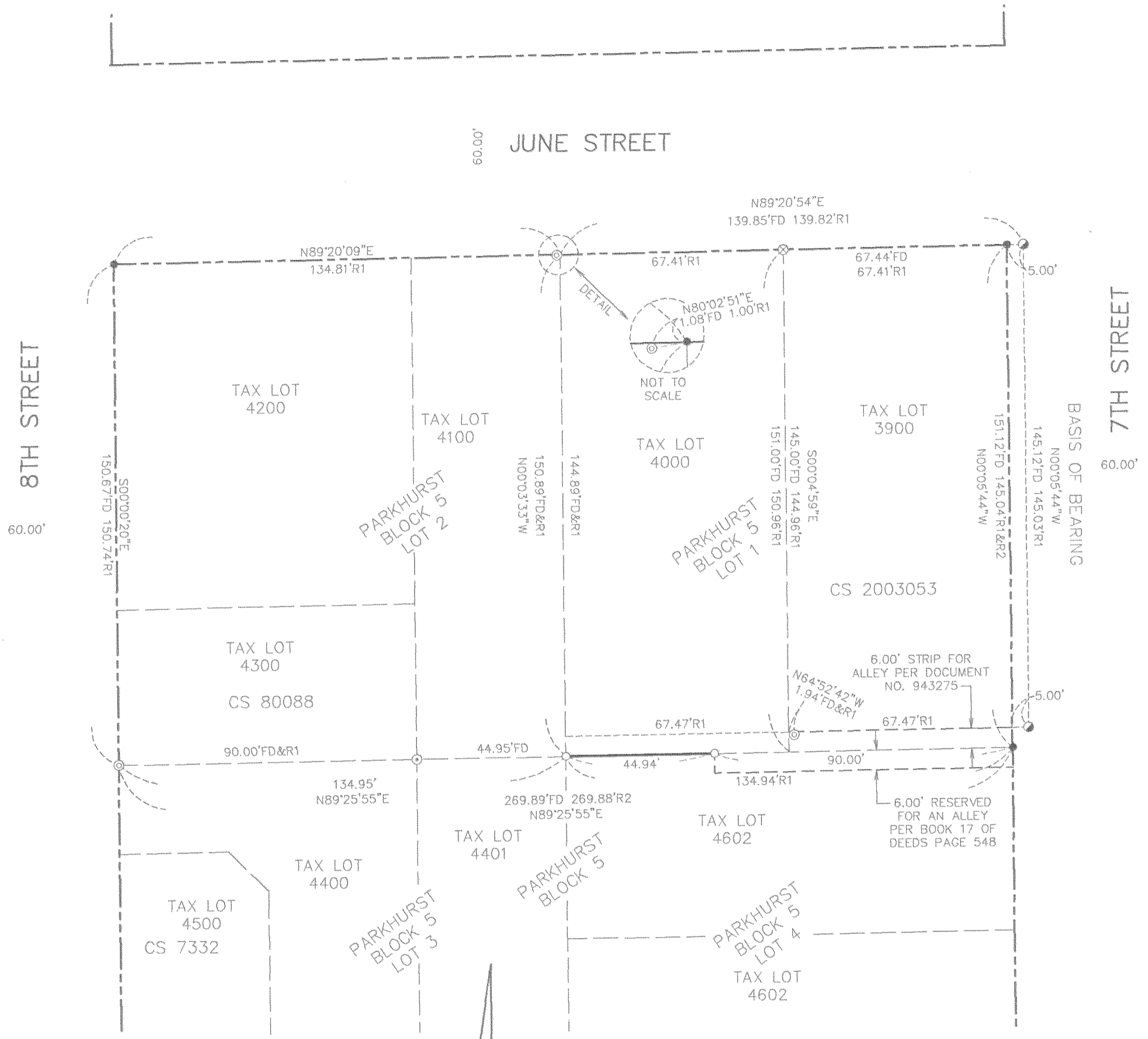


# RECORD OF SURVEY

THE NORTH 55.00 FEET OF LOT 4, BLOCK 5, PARKHURST ADDITION TO THE CITY OF HOOD RIVER, IN THE COUNTY OF HOOD RIVER, STATE OF OREGON, LOCATED IN THE NORTHWEST QUARTER OF SECTION 36, TOWNSHIP 3 NORTH, RANGE 10 EAST OF THE WILLAMETTE MERIDIAN.

## NARRATIVE OF SURVEY

THE PURPOSE OF THIS SURVEY IS TO RETRACE A PORTION OF THE NORTH LINE OF THAT CERTAIN PARCEL DESCRIBED BY DOCUMENT NO. 20023405 ON FILE IN HOOD RIVER, COUNTY OREGON, NORTHWEST QUARTER OF SECTION 36, TOWNSHIP 3 NORTH, RANGE 10 EAST OF THE WILLAMETTE MERIDIAN.

THE BASIS OF BEARING FOR THIS SURVEY WAS ESTABLISHED WYEAST SURVEYS ON SURVEY NO. 2003053. MONUMENTS WERE FOUND AND HELD AS SHOWN ON SAID SURVEY AND MONUMENTS WERE SET AT THE NORTHWEST CORNER OF LOT 4, BLOCK 5 PARKHURST ADDITION AND AT A POINT 44.94 FEET EAST OF SAID NORTHWEST CORNER.

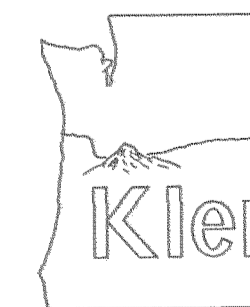

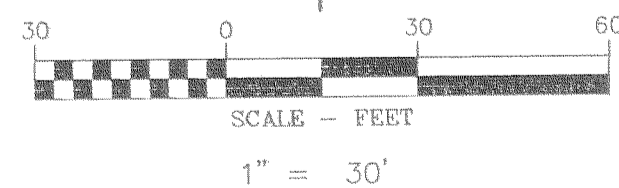
