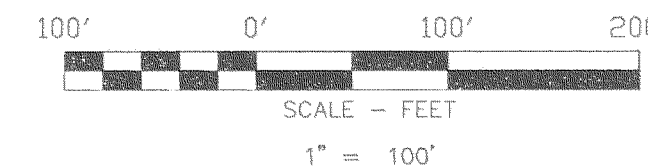

NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO LOCATE THE NORTH ONE HALF OF THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 30, TOWNSHIP 2 NORTH, RANGE 10 EAST OF THE WILLAMETTE MERIDIAN WHICH IS DESCRIBED AS TAX LOT 300. A PVIOUS SURVEY PERFORMED BY BISHOP SURVEYING (CS NO. 80082) LOCATED THE EXTERIOR OF SECTION 30. A FOUND 5/8" IRON ROD SET BY BISHOP SURVEYING AT THE NORTHWEST CORNER OF SECTION 30 AND A 2-1/2" BRASS CAP AT THE WEST 1/16" CORNER WAS HELD FOR THE BASIS OF THIS SURVEY. A CLOSED LOOP TRAVERSE WAS RAN AROUND THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 30.
