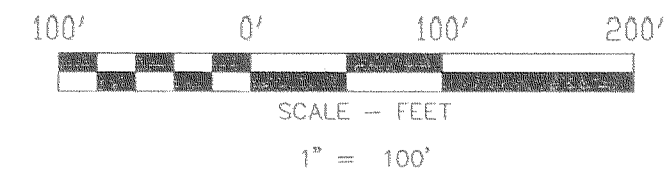

THE PURPOSE OF THIS SURVEY IS TO RETRACE THE PERIMETER BOUNDARY OF THAT CERTAIN TRACT OF LAND DESCRIBED BY WARRANTY DEEDS RECORDED IN DOCUMENT NO.'S 663124 AND 701515 AND BOOK 72, PAGE 26 AND BOOK 77, PAGE 594 ON FILE IN HOOD RIVER COUNTY, OREGON LOCATED IN THE NORTHWEST QUARTER OF SECTION 13, TOWNSHIP 2 NORTH, RANGE 7 EAST, OF THE WILLAMETTE MERIDIAN.

A SURVEY PERFORMED BY BISHOP SURVEYING AND RECORDED AS HOOD RIVER COUNTY SURVEY NO. 87047 SURVEYED AND ESTABLISHED THE EAST, SOUTH AND WEST BOUNDARIES AND A SURVEY PERFORMED BY TERRA SURVEYING AND RECORDED AS HOOD RIVER COUNTY SURVEY NO. 98030 ESTABLISHED THE NORTH BOUNDARY. THIS SURVEY FOUND AND HELD MONUMENTS AS SET BY BISHOP AND TERRA AND ESTABLISHED TWO ADDITIONAL MONUMENTS AS SHOWN HERON.

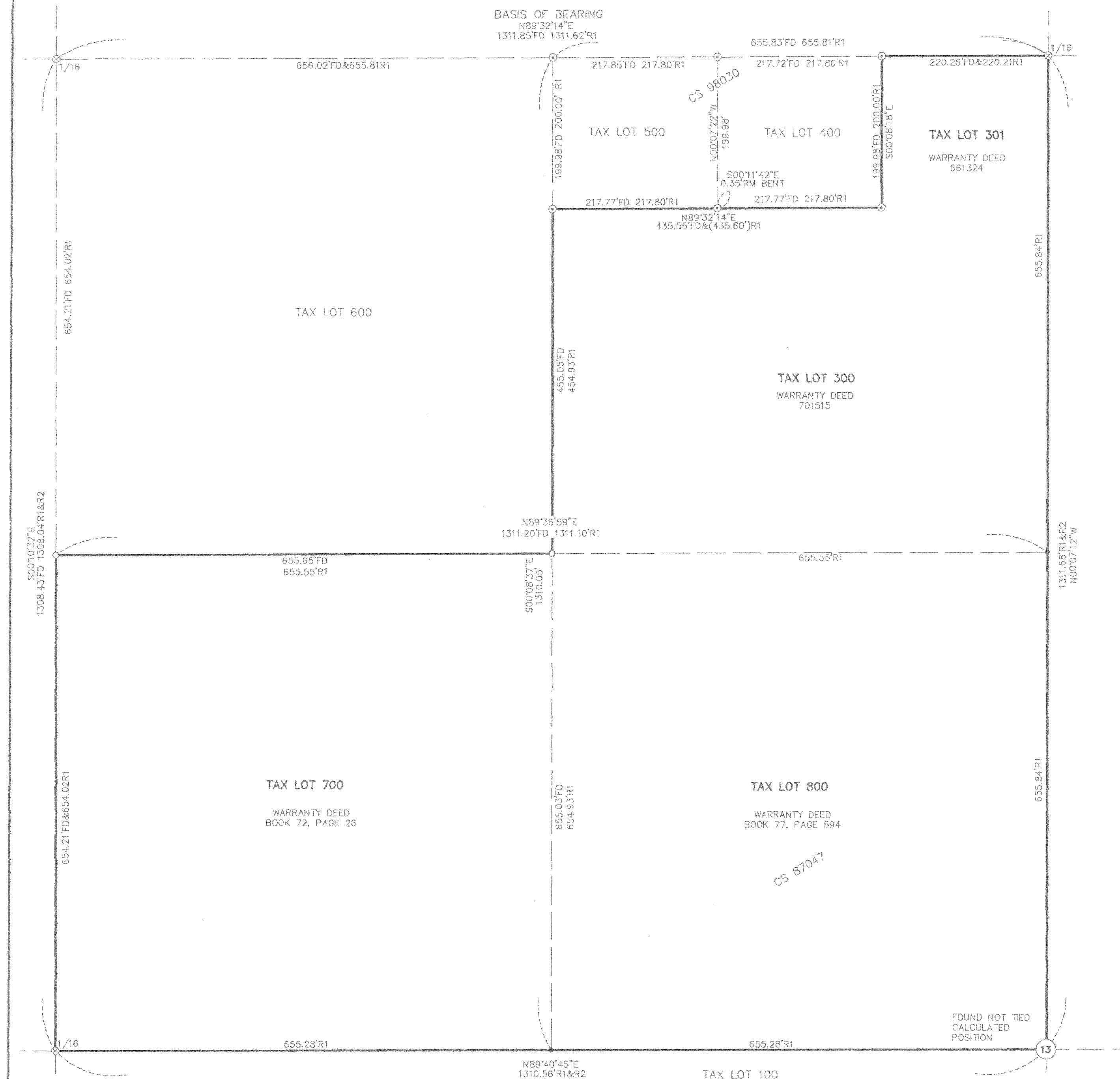
