
Boundary Survey located in NE1/4 of Section 22, T.1N., R10E., W.M. Hood River County, Oregon

History and Narrative

The purpose of this survey was to mark the perimeter of the south half of Gov't Lot 2, and a portion of the north half of Gov't Lot 7 in the NE 1/4 of Section 22, T.1 N., R.10 E., W.M., Hood River County,

LS 1028 subdivided the northeast quarter of section 22 in 1976, calling to a found pipe, but using his own position for the C1/4 Section 22 (CS 7641). This breakdown was perpetuated in other surveys done by LS1028 in Gov't Lot 2 (CS 86043), specifically in the two surveys done for Peter Hofmann of these parcels in 1994 and 1996 (CS 94018 and CS 96084)

Later surveys, accepting the found pipe as the C1/4 of section 22, shortened the distance of the north half of Gov't Lot 2 by 0.8 ft. (CS 84043, 99021, and 2001-055)

This survey tied the current Hood River County monuments at the N1/4 and the C1/4 of section 22 for basis of bearing. We held the location for the northwest corner of the south half of Gov't Lot 2 as per CS 84043 and 2001055 and tied found monuments along the perimeter as shown. The location of the r/w monument set by LS 932, near the northwest corner of the south half of gov't lot 2 (CS 84043) fell in the mowed area and was not recovered. This survey set PK nails on the centerline, (which actually falls in the existing northbound lane of Miller road) and witness corners 30' east from centerline, hopefully not to be disturbed. T-iron fence posts were set alongside and along the north and south lines, east to the irrigation ditch (tops painted orange).

The perimeter lines easterly of the irrigation canal posted by LS1028 (CS 96084) were located and flagged, and trees along these lines were blazed and painted with orange paint.


