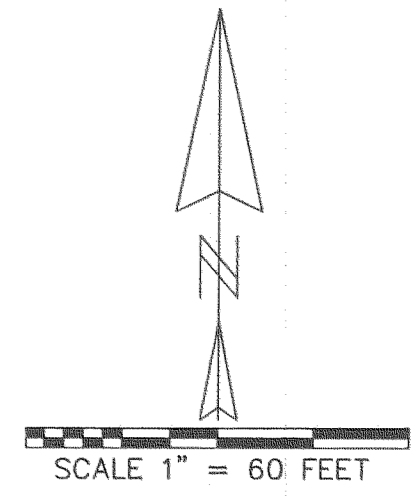
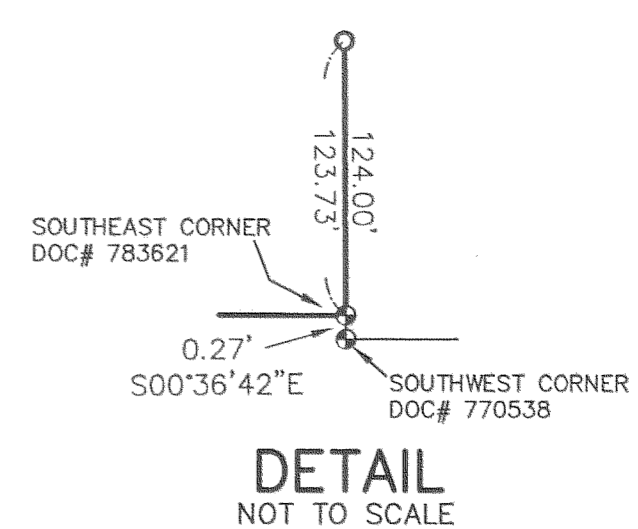
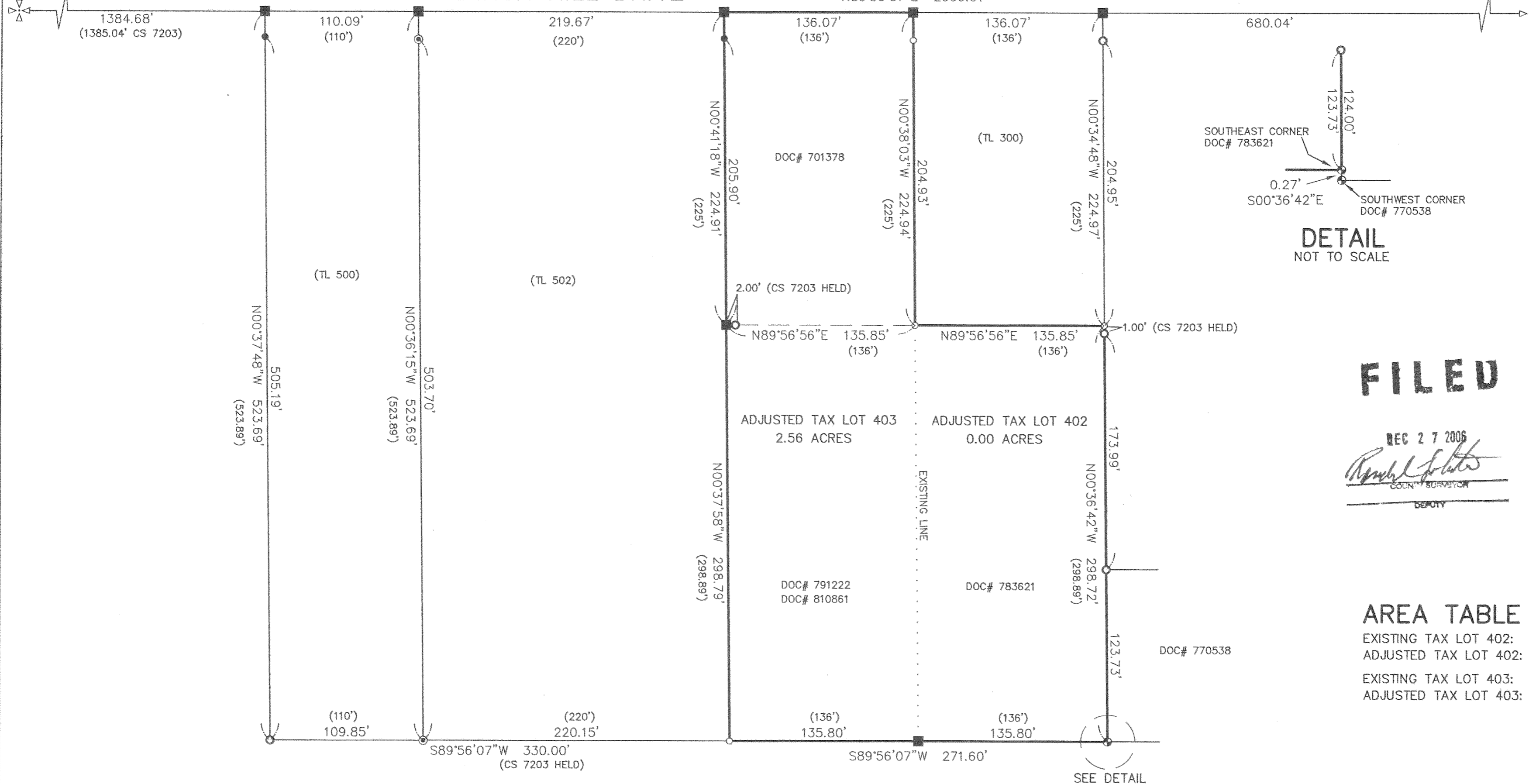

**NARRATIVE:**

THE PURPOSE OF THIS SURVEY IS TO FILE FOR RECORD A PROPERTY LINE ADJUSTMENT BY WHICH THAT TRACT OF LAND DESCRIBED IN DEED RECORDED AS DOC# 783621 (TAX LOT 402) IS ADJUSTED TO THAT TRACT OF LAND DESCRIBED IN DEED RECORDED AS DOC# 810861 (TAX LOT 403) AND ALSO TO MONUMENT THE BOUNDARIES OF ADJUSTED TAX LOT 403. CS 7203 WHICH HAD PREVIOUSLY MONUMENTED PORTIONS OF THE SUBJECT PROPERTIES WAS USED AS A BASIS FOR THIS SURVEY. THIS SURVEY ACCEPTED MONUMENTS IN THEIR FOUND POSITION FROM THE VARIOUS REFERENCED SURVEYS AS SHOWN. THE SOUTHWEST CORNER OF TAX LOT 403 WAS ESTABLISHED AT RECORD DISTANCE EAST OF THE IRON ROD FOUND AT THE SOUTHWEST CORNER OF TAX LOT 500. THE SOUTHEAST CORNER OF TAX LOT 402 WAS ESTABLISHED BY BEARING-BEARING INTERSECTION, THE NORTHEAST CORNER OF TAX LOT 402 WAS ESTABLISHED AT RECORD DISTANCE NORTH OF THE FOUND REFERENCE MONUMENT. THE NORTHWEST CORNER OF THAT TRACT OF LAND DESCRIBED IN DOC# 791222 (BEING A PORTION OF TAX LOT 403) WAS ESTABLISHED AT RECORD DISTANCE WEST OF THE FOUND REFERENCE MONUMENT. THE NORTHWEST CORNER OF TAX LOT 402 WAS ESTABLISHED AT MIDPOINT BETWEEN THE ABOVE MENTIONED CORNERS. THE NORTHEAST CORNER OF TAX LOT 300 AND THE NORTHWEST CORNER OF TAX LOT 403 WERE ESTABLISHED BY BEARING-BEARING INTERSECTION. THE NORTHEAST CORNER OF TAX LOT 403 WAS ESTABLISHED AT MIDPOINT BETWEEN THE ABOVE MENTIONED CORNERS.
