


NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO LOCATE THE BOUNDARY OF TAX LOT 6500 OF ASSESSOR MAP 1N 09E 13, TAX LOT 6500 IS DESCRIBED IN STATUTORY WARRANTY DEED TO GARY W. STEELE AND NANCY J. STEELE. IN MICROFILM NO. 970246, DATED JANUARY 22, 1997, HOOD RIVER COUNTY DEED RECORDS.

A SURVEY PERFORMED BY WYEAST SURVEYS ON TAX LOT 5500 AND 5700 OF ASSESSOR MAP IN 9E 13, ESTABLISHED THE WEST 1/2 OF THE SOUTHEAST 1/4 OF SECTION 13, WHICH WAS HELD IN THIS SURVEY. A FOUND BRASS CAP IN A MONUMENT CASE AT THE INTERSECTION OF LOST LAKE ROAD, CARSON HILL ROAD AND ALDER ROAD AND A 1-1/2" IRON PIPE AT THE INTERSECTION OF CARSON HILL ROAD AND COLLINS ROAD WAS HELD AS THE BASIS OF BEARING FOR THIS SURVEY. SAID BEARING IS BASED ON A SURVEY PERFORMED BY KLEIN & ASSOCIATES IN COUNTY SURVEY NO. 98049. TWO EXISTING 3/4" IRON PIPES AND ONE 1-1/2" IRON PIPE WERE FOUND WITHIN 4' + OF THE COMPUTED BOUNDARY, SAID MONUMENTS WERE NOT ACCEPTED IN THIS SURVEY. A SURVEY PERFORMED BY DIELSCHNEIDER & ASSOC., INC., RECORDED IN COUNTY SURVEY NO. 85085, LOCATED A 1" IRON PIPE 19.58' WEST OF THE INTERSECTION OF LOT 46 AND COLLINS ROAD. THE DISTANCES IN SAID SURVEY CLOSELY MATCH THE COMPUTED WEST 1/2 OF THE SOUTHEAST 1/4 AS COMPUTED BY WYEAST SURVEYS, SAID 1" IRON PIPE WAS ASSUMED TO BE THE SAME IRON PIPE AS FOUND IN THIS SURVEY. SAID POSITION OF IRON PIPES DID NOT FIT THE LOCATION OF SAID WYEAST SURVEYS OR DIELSCHNEIDER AND WERE NOT ACCEPTED.


