




A PARTITION PERFORMED BY BELL DESIGN RECORDED AS PARTITION PLAT 2001-26P, AND RECORDED IN COUNTY SURVEY NO. 2001-071, WAS USED AND HELD FOR THE BASIS OF BEARING FOR THIS SURVEY.
