



#### NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO LOCATE THE BOUNDARY OF TAX LOT 401 OF HOOD RIVER COUNTY ASSESSOR MAP 2N 10E 8. SAID TAX LOT IS DESCRIBED IN THAT CERTAIN WARRANTY DEED RECORDED AS INSTRUMENT NO. 930353 TO TOM McGOWAN AND BRENDA McGROWAN.

TAX LOT 401 IS DESCRIBED AS THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 8, TOWNSHIP 2 NORTH, RANGE 10 EAST OF THE WILLAMETTE MERIDIAN, IN THE COUNTY OF HOOD RIVER, STATE OF OREGON, EXCEPT THAT PORTION IN YORK HILL ROAD.

THE SECTIONAL BREAK DOWN OF THE NORTHEAST QUARTER OF SECTION 8 WAS PERFORMED BY ANDERSON PERRY & ASSOCIATES RECORDED IN COUNTY SURVEY NO. 98064 WHICH HELD THE COMPUTED CENTER OF SECTION AND NOT THE ALUMINUM CAP SET BY HOOD RIVER COUNTY SURVEY'S OFFICE. A SURVEY PERFORMED BY TRANTOW SURVEYING RECORDED AS COUNTY SURVEY NO. 2006-062, ALSO LOCATED THE EXTERIOR OF THE NORTHEAST QUARTER OF SECTION 8 AND IN WHICH HE AGREED WITH AFORE SAID SURVEY PERFORMED BY ANDERSON PERRY & ASSOCIATES. FOR THE PURPOSE OF THIS SURVEY OUR FIRM HELD THE COMPUTED CENTER OF SECTION AS PER AFORE SAID SURVEYS. TWO MONUMENTS SET ALONG THE WEST LINE OF TAX LOT 401 BY TRANTOW SURVEYING WERE FIELD LOCATED AND HELD IN THIS SURVEY. MONUMENTS WERE THEN SET ALONG THE EAST LINE OF THE ABOVED DESCRIBED DESCRIPTION IN WHICH SAID EAST LINE FIT LOCATION OF AN EXISTING FENCE .
