


PROPERTY BOUNDARY LINE ADJUSTMENT SURVEY FOR HOOD RIVER COUNTY.

LOCATED IN THE SW 1/4 OF SECTION 25, TOWNSHIP 3 NORTH, RANGE 10 EAST W.M., PORTION OF PARCEL 1 OF PARTITION PLAT 9617

TAX LOTS 108 & 120, 3N-10E-25.

CORNER MONUMENT NOTES:

- 1. 5/8" IRON ROD FOUND WITH NO CAP, ACCEPTED AS BEING THE NORTHEAST CORNER OF PARTITION PLAT 9617. LIKELY FROM C.S.#84075.
- 2. 5/8" IRON ROD FOUND WITH NO CAP, ACCEPTED AS BEING THE NORTHEAST CORNER OF PARCEL 1 OF PARTITION PLAT 9617. IT IS LIKELY THAT THE CAP WAS DESTROYED AND THE MONUMENT IS FROM PARTITION PLAT 9617.
- 3. 5/8" IRON ROD FOUND WITH NO CAP AT THE SOUTHWEST CORNER OF TAX LOT 102.
- 4. 5/8" IRON ROD FOUND WITH DAMAGED YELLOW CAP. IT IS LIKELY THAT THE MONUMENT IS FROM PARTITION PLAT 9617. THE MONUMENT IS BURIED APPROXIMATELY 12".
- 5. 5/8" IRON ROD FOUND WITH NO CAP, ACCEPTED AS BEING THE MONUMENT SHOWN AS THE SOUTHEAST CORNER OF PARTITION PLAT 9617. THE MONUMENT IS NOT ON THE TRUE RIGHT OF WAY AS PER THE CENTERLINE MONUMENTS SET BY C.S.#99036. I HELD IT FOR LINE AND EXTENDED THE EAST LINE OF PARTITION PLAT 9617 TO THE TRUE RIGHT OF WAY. I DID NOT SET A NEW MONUMENT ON THE RIGHT OF WAY.
- 6. 5/8" IRON ROD FOUND WITH YELLOW PLASTIC CAP INSCRIBED "PLS 0872". SHOWN ON PARTITION PLAT 9617 AS BEING ON THE RIGHT OF WAY 45 FEET FROM THE CENTERLINE OF RIVERSIDE DRIVE AT THE START OF THE 200' LONG CENTERLINE SPIRAL CURVE. THE MONUMENT IS NOT ON THE TRUE RIGHT OF WAY AS PER THE CENTERLINE MONUMENTS SET BY C.S.#99036, THE MONUMENT IS BURIED APPROXIMATELY 12".
- 7. 5/8" IRON ROD FOUND WITH YELLOW PLASTIC CAP INSCRIBED "PSO 872". ACCEPTED AS BEING THE MONUMENT SHOWN AS THE SOUTHWEST CORNER OF PARTITION PLAT 9617. THE MONUMENT IS NOT ON THE TRUE RIGHT OF WAY AS PER THE CENTERLINE MONUMENTS SET BY C.S.#99036. I HELD IT FOR LINE AND EXTENDED THE WEST LINE OF PARTITION PLAT 9617 TO THE TRUE RIGHT OF WAY. I DID NOT SET A NEW MONUMENT ON THE RIGHT OF WAY.
- 8. 5/8" IRON ROD FOUND WITH YELLOW PLASTIC CAP INSCRIBED "PLS 994". LIKELY FROM C.S.#84075. ACCEPTED AS BEING THE POINT OF CURVATURE FOR THE RIGHT OF WAY
 AS SHOWN ON PARTITION PLAT 9617. THE MONUMENT IS BURIED APPROXIMATELY 14"
- 9. 5/8" IRON ROD FOUND WITH YELLOW PLASTIC CAP INSCRIBED "PLS 994". LIKELY FROM C.S.#84075. ACCEPTED AS BEING THE SOUTHWEST CORNER OF PARTITION PLAT 9617.
- 10. 5/8" IRON ROD FOUND WITH NO CAP, ACCEPTED AS BEING THE NORTHWEST CORNER OF PARTITION PLAT 9617. LIKELY FROM C.S.#84075.
- 11. 5/8" IRON ROD FOUND WITH DAMAGED YELLOW CAP, ACCEPTED AS BEING THE NORTHWEST CORNER OF PARCEL 1 OF PARTITION PLAT 9617.
 12. 5/8" IRON ROD FOUND WITH SUN BLEACHED CAP, ANY INSCRIPTION IS INELIGIBLE. THE MONUMENT IS 0.12' WEST OF THE WEST LINE OF PARCEL 1 AND I AM NOT SURE AS TO ITS ORIGIN OR PURPOSE
- 13. 1/2" IRON ROD FOUND WITH DAMAGED YELLOW CAP. IT IS LIKELY THAT THE MONUMENT IS FROM PARTITION PLAT 9617.
- 14. 5/8" IRON ROD FOUND WITH RED PLASTIC CAP INSCRIBED "PLS 1815". I DID NOT LOCATE THE SURVEY THAT ESTABLISHED THE MONUMENT, HOWEVER IT IS SHOWN ON C.S.#2008036 AS MONUMENTING THE 40' WIDE EASEMENT ALONG THE WEST LINE OF PARTITION PLAT 9617.

ADJUSTED PORTION LEGAL DESCRIPTION:

The Northerly 137 feet of Parcel 1 of Partition Plat No.9617, recorded June 14, 1996, being a portion of the Northeast Quarter of the Southwest Quarter of Section 25, Township 3 North, Range 10 East of the Willamette Meridian, in the County of Hood River County and State of Oregon.

NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO ADJUST THE NORTHERLY LINE OF TAX LOT 120, 137 FEET TO THE SOUTH INTO TAX LOT 108 AS SHOWN. TAX LOT 108 IS DESCRIBED BY AMERITITLE PRELIMINARY TITLE REPORT No.1, TITLE No.0039862, DATED DECEMBER 4, 2008, AND ALSO BY WARRANTY DEED DOCUMENT No.2008-04670 AS BEING PARCEL 1 OF PARTITION PLAT 9617. I FOUND ALL THE ORIGINAL MONUMENTATION FROM PARCEL 1 OF PARTITION PLAT 9617. I THEN SET TWO NEW MONUMENTS TO ADJUST THE LINE BETWEEN TAX LOTS 108 AND 120 AS PER CLIENT INSTRUCTION.

ADJUSTED

THE SOUTHERLY LINE OF PARCEL 1, BEING THE NORTHERLY RIGHT OF WAY OF RIVERSIDE DRIVE IS SHOWN WITH RESPECT TO THE CENTERLINE MONUMENTED BY C.S.#99036, AN O.D.O.T. MONUMENTATION SURVEY CONDUCTED AFTER PARTITION PLAT 9617. THE CENTERLINE MONUMENTS FIT THE AS CONSTRUCTED ROADWAY. THE MONUMENTS SET ON THE RIGHT OF WAY BY PARTITION PLAT 9617 ARE NOT ON THE RIGHT OF WAY AS DEFINED BY THE MONUMENTS SET FOR C.S.#99036. I HELD THE MONUMENTS FROM PARTITION PLAT 9617 FOR THE EAST AND WEST LINES OF PARCEL 1 AND EXTENDED OR SHORTENED THE LINES TO THE RIGHT OF WAY DEFINED BY C.S.#99036. I HELD THE MONUMENTS FOUND AT THE ENDS OF THE CIRCULAR CURVE AND HELD THE LOCATION OF THE SPIRAL CURVES DESCRIBED BY C.S.#99036 WITH RESPECT TO THESE MONUMENTS, THE OTHER MONUMENTS FOUND FOR THE SPIRAL CURVE FELL VERY CLOSE TO THE CALCULATED LOCATIONS. I THEN OFFSET THE CENTERLINE AS DEFINED BY THE RIGHT OF WAY TAKING DESCRIBED BY WARRANTY DEED MICROFILM No.943591. I DID NOT SET NEW MONUMENTS ON THE RIGHT OF WAY.

AN ADDITIONAL UTILITY EASEMENT IN FAVOR OF THE POT OF HOOD RIVER, RECORDED JANUARY 20, 1969, AS MICROFILM No.690072 IS SHOWN ON THE PRELIMINARY TITLE REPORT BUT IS NOT SHOWN ON THIS SURVEY. THE PRELIMINARY TITLE REPORT ALSO CONTAINS OTHER EXCEPTIONS.

THE FOUNDATION SHOWN ON PARCEL 1 APPEARS TO BE FOR AN ABANDONED DEVELOPMENT PROJECT. THERE IS EVIDENCE OF UNDERGROUND UTILITIES NOT COVERED BY EASEMENTS WHICH ALSO APPEAR TO BE ABANDONED.
