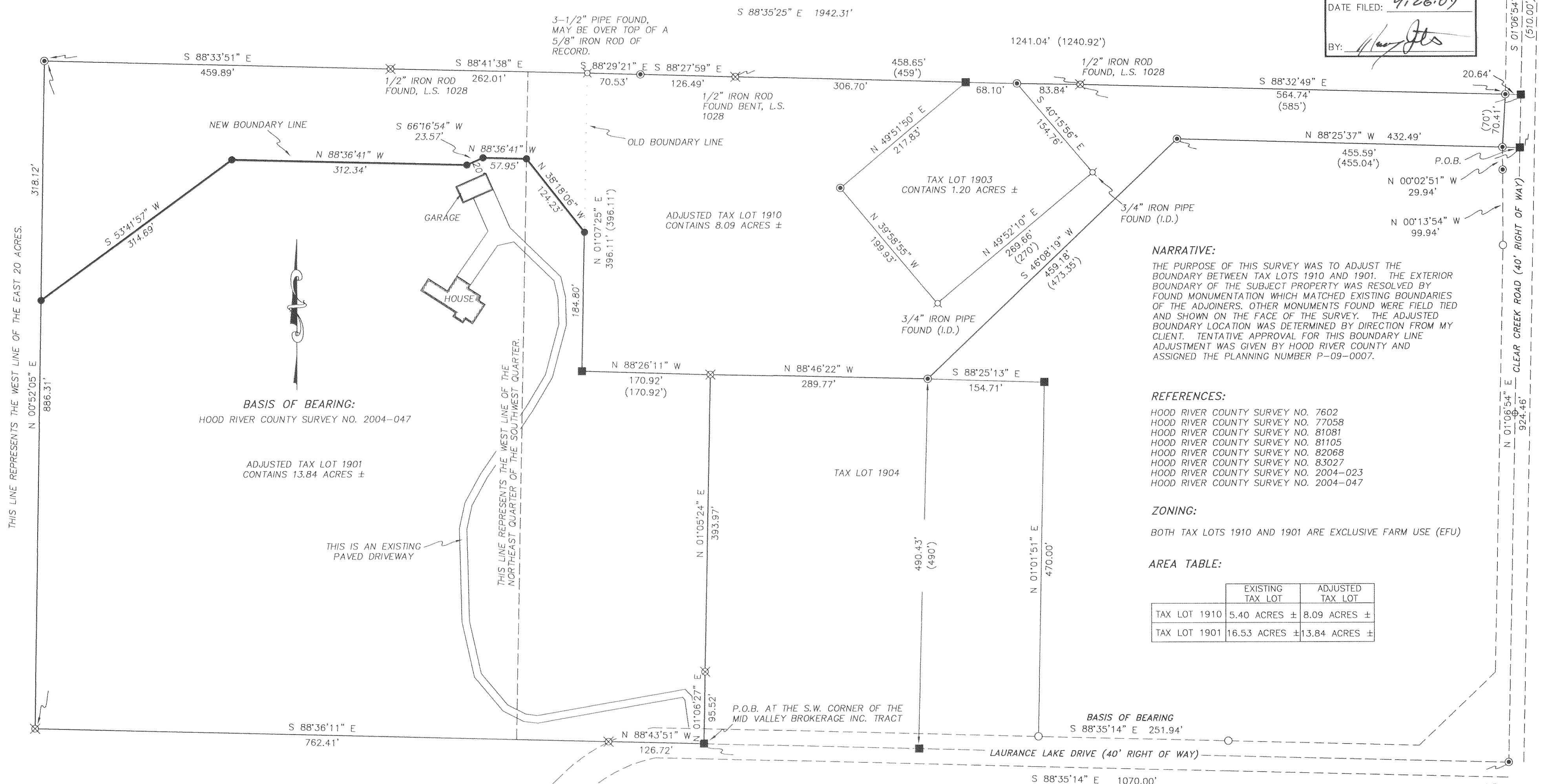

LOCATION OF SURVEY:

A PARCEL OF LAND LOCATED IN THE SOUTHWEST QUARTER OF SECTION 18, TOWNSHIP 1 SOUTH, RANGE 10 EAST, WILLAMETTE MERIDIAN, HOOD RIVER COUNTY OREGON.



NARRATIVE:
 THE PURPOSE OF THIS SURVEY WAS TO ADJUST THE BOUNDARY BETWEEN TAX LOTS 1910 AND 1901. THE EXTERIOR BOUNDARY OF THE SUBJECT PROPERTY WAS RESOLVED BY FOUND MONUMENTATION WHICH MATCHED EXISTING BOUNDARIES OF THE ADJOINERS. OTHER MONUMENTS FOUND WERE FIELD TIED AND SHOWN ON THE FACE OF THE SURVEY. THE ADJUSTED BOUNDARY LOCATION WAS DETERMINED BY DIRECTION FROM MY CLIENT. TENTATIVE APPROVAL FOR THIS BOUNDARY LINE ADJUSTMENT WAS GIVEN BY HOOD RIVER COUNTY AND ASSIGNED THE PLANNING NUMBER P-09-0007.

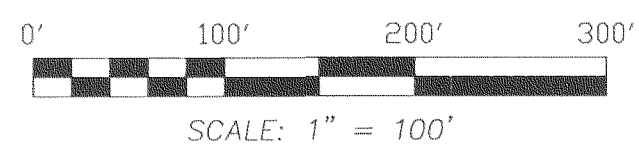
