#### NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO PERFORM A BOUNDARY LINE ADJUSTMENT FOR THE CONVEYANCE OF THE WEST 40 FEET, MORE OR LESS, OF TAX LOT 1000 OF HOOD RIVER COUNTY ASSESSORS MAP 3N-10E-26CB, TO THE OWNERS OF TAX LOT 1100 TO THE WEST.

HOOD RIVER COUNTY STATUTORY WARRANTY DEED DOCUMENT No. 20023790 DESCRIBES A TRACT OF LAND SIMILAR TO THAT SURVEYED FOR C.S.#80048, BEING TAX LOT 1000. THE DEED FOR TAX LOT 1000 DOES NOT INCLUDE ANY LAND NORTH OF THE SOUTHERLY RAILROAD RIGHT OF WAY. THE RELEVANT ASSESSORS MAP SHOWS A PORTION OF TAX LOT 1000 ON THE NORTH SIDE OF THE RAILROAD RIGHT OF WAY WHICH APPEARS TO BE IN ERROR. I FOUND AN IRON ROD FROM C.S.#80048 AT THE SOUTHWEST CORNER OF TAX LOT 1000 CLOSE TO THE LOCATION DESCRIBED BY THE DEED AND ACCEPTED ITS POSITION. I ALSO FOUND AN IRON ROD NEAR THE TOP OF THE BLUFF THAT FELL CLOSE TO THE WEST LINE OF TAX LOT 1000 AS VERIFIED BY ITS DISTANCE FROM THE WEST LINE OF TAX LOT 1100 AS ESTABLISHED BY C.S.#87073. I ASSUME THIS ROD WAS SET DURING THE C.S.#80048 SURVEY ALTHOUGH IT IS NOT SHOWN, I ACCEPTED IT FOR LINE, I FOUND AN IRON ROD SET FOR C.S.#80048 AT THE SOUTHWEST CORNER OF TAX LOT 1001 CONSISTENT WITH THE DEED POSITION, I THEN SET A NEW MONUMENT ON THE HIGHWAY RIGHT OF WAY 40 FEET FAST OF THE PREVIOUSLY MONUMENTED, WEST LINE OF TAX LOT 1000 AND 3 ADDITIONAL MONUMENTS TO THE NORTH ALONG A LINE 40 FEET EAST OF THE WEST LINE OF TAX LOT 1000 UP TO THE EDGE OF THE BLUFF.

THE 100 FOOT WIDE RAILROAD RIGHT OF WAY IS SHOWN DIGITIZED AS PER HOOD RIVER COUNTY AFRIAL IMAGERY OBTAINED FROM THE COUNTY WEBMAP SERVICE TO AID IN ACREAGE CALCULATION. NO MONUMENTS WERE SET NORTH OF THE BLUFF DUE TO THE DIFFICULTY IN ACCESS TO THE LAND BELOW.

ADDITIONAL EASEMENTS ARE LISTED ON WARRANTY DEED DOCUMENT No.20060998 WHICH ARE NOT SHOWN.

## ADJUSTED PORTION LEGAL DESCRIPTION:

The westerly 40 feet, more or less, of the tract of land conveyed to Aileen M. Steeves-Pobanz, Trustee of the Aileen M. Steeves-Pobanz Revocable Trust UTA DTD July 25, 2002, or the successor trustee thereto, by Statutory Warranty Deed recorded August 9, 2002, as Document No.20023790, Deed Records of Hood River County, located in the Northwest quarter of the Southwest quarter of Section 26, Township 3 North, Township 3 North, Range 10 East of the Willamette Meridian, in the County of Hood River, and State of Oregon described as follows:

Commencing at the Northwest corner of the Northwest quarter of the Southwest quarter of said Section 26; thence East along the North line of the Northwest quarter of the Southwest quarter of said Section 26, a distance of 313.5 feet to the Northeast corner of that tract of land conveyed to F.S. Smith by deed recorded July 18, 1908, in Book 1 at page 20, Deed Records of Hood River County being the true place of beginning of the tract of land herein described; thence South 00°22'58" East along the East line of said Smith tract of land a distance of 615.04 feet to the Northerly line of that certain strip of land, 275 feet in width, conveyed to the State of Oregon, by and through its State Highway Commission, by deed from W.R. McWilliams et ux, recorded August 10, 1951, in Book 45 at page 578, Deed Records of Hood River County, which said Northerly line of said strip of land is 100 feet North of, measured at right angles to, the center line of the re-located Columbia River Highway; thence along the Northerly right of way line of said re-located Columbia River Highway on the arc of a 5829.58 foot radius curve right, a distance of 40.39 feet (the chord of which bears North 81°40'12" East a distance of 40.39 feet) to a 5/8" iron rod with orange plastic cap inscribed "CROSS PLS 60051"; thence North 00°22'58" West a distance of 136.62 feet to a similar 5/8" iron rod with orange plastic cap inscribed "CROSS PLS 60051"; thence North 00°22'58" West a distance of 71.20 feet to a similar 5/8" iron rod with orange plastic cap inscribed "CROSS PLS 60051"; thence North 00°22'58" West a distance of 141.47 feet to a similar 5/8" iron rod with orange plastic cap inscribed "CROSS PLS 60051"; thence North 00°22'58" West a distance of 112.23 feet, more or less, to the Southerly right of way line of the Union Pacific Railroad (previously known as the Oregon-Washington Railroad and Navigation Company); thence North 00°22'58" West a distance of 147.76 feet, more or less, to the North line of the Northwest quarter of the Southwest quarter of said Section 26; thence West along the North line of the Northwest quarter of the Southwest quarter of said Section 26 a distance of 40 feet, more or less; to the point of beginning; EXCEPTING THEREFROM, however, all that portion thereof lying Northerly of the Southerly right of way line of the Union Pacific Railroad (previously known as the Oregon-Washington Railroad and Navigation Company).
