

NARRATIVE

THE PORTION OF THE POWERDALE HYDROELECTRIC PROJECT BOUNDARY WHICH LIES 20 FEET WESTERLY OF THE CENTERLINE OF THE CANAL FLUME LOCATED IN THE SOUTHEAST ONE—QUARTER OF THE SOUTHWEST ONE—QUARTER OF THE NORTHWEST ONE—QUARTER (SE1/4 SW1/4 NW1/4) OF SECTION 12, TOWNSHIP 2 NORTH, RANGE 10 EAST, W.M. WAS SURVEYED BY MARK HEIDECKE, OR PLS 2132, IN 1995 (CS 95111). NO MONUMENTS WERE SET ALONG THIS BOUNDARY LINE PER CS 95111. THE FLUME IS CURRENTLY BEING REMOVED. WE WERE RETAINED BY PACIFICORP TO SET THE MONUMENTS MARKING THIS BOUNDARY.

CONTROL FOR THIS SURVEY WAS ESTABLISHED USING R.T.K. G.P.S. AND CALIBRATING TO THE COORDINATE POSITIONS SHOWN ON SAID CS 95111 FOR THE NORTHEAST CORNER, THE SOUTHEAST CORNER AND THE WEST ONE—QUARTER CORNER OF SECTION 12.

OUR MEASURED DATA BETWEEN THE WEST ONE—QUARTER CORNER AND EAST ONE—QUARTER CORNER OF SECTION 12 MATCHED THE CS 95111 RECORD DATA EXACTLY. THE BEARING OF THIS LINE IS BEING HELD AS THE BASIS OF BEARING FOR THIS SURVEY.

WE HELD THE RECORD CS 95111 DATA TO ESTABLISH THE POSITIONS FOR THE MONUMENTS WE SET.

WE LOCATED PORTIONS OF THE EXISTING FLUME WHICH WERE IN THE PROCESS OF BEING REMOVED AS WELL AS EVIDENCE OF SCARS IN THE EARTH WHERE THE FLUME HAD BEEN REMOVED TO VERIFY THAT OUR MONUMENTS FELL 20 FEET WEST OF THE FLUME LOCATION.
