NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO ESTABLISH THE BOUNDARIES OF THAT TRACT OF LAND DESCRIBED IN DEED RECORDED AS DOC NO. 20032266. THE SUBJECT TRACT IS ONE OF FOUR TRACTS THAT HAVE BEEN CREATED FROM A PARENT TRACT THAT IS 330 FEET WIDE OFF THE SOUTH END OF THE SW 1/4 OF THE NW 1/4 OF SECTION 10. THE EASTERLY TRACT IS DESCRIBED AS THE EAST 313 FEET OF THE PARENT TRACT. THE WESTERLY TRACT IS DESCRIBED AS THE WEST 380 FEET OF THE PARENT TRACT. THE REMAINING TWO TRACTS ARE DESCRIBED AS THE EAST HALF AND WEST HALF OF THE REMAINDER. I HAD PREVIOUSLY ESTABLISHED THE BOUNDARIES OF THE WEST HALF OF THE NORTHWEST QUARTER. THE RECORD OF THAT SURVEY IS FILED AS CS 2006 084. TO CONDUCT THIS SURVEY I RECOVERED AND VERIFIED CONTROL FROM THE 2006 SURVEY. THE NORTHWEST CORNER OF THE PARENT TRACT WAS ESTABLISHED ALONG THE WEST LINE OF THE NORTHWEST QUARTER AT DEED DISTANCE NORTH OF THE WEST QUARTER CORNER. THE NORTHEAST CORNER OF THE PARENT TRACT WAS ESTABLISHED ALONG THE EAST LINE OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER AT THE INTERSECTION OF A LINE PROJECTED FROM THE NORTHWEST CORNER PARALLEL WITH THE SOUTH LINE OF THE NORTHWEST QUARTER. AN IRON ROD AND DRILL HOLE WERE FOUND FROM CS 2009 013 TO ESTABLISH THE WEST LINE OF THE EAST 313 FEET OF THE PARENT TRACT. THE EAST LINE OF THE WEST 380 FEET OF THE PARENT TRACT WAS ESTABLISHED 380 FEET EAST OF AND PARALLEL WITH THE WEST LINE OF THE NORTHWEST QUARTER. THE EAST AND WEST HALF OF THE REMAINDER WAS ESTABLISHED BY AREA CALCULATION. A MEAN BEARING WAS USED FOR THE DIRECTION OF THE DIVISION LINE.
