

NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO LOCATE THE EXTERIOR BOUNDARY OF TAX LOT 1600 OF HOOD RIVER COUNTY ASSESSOR MAP 2N 10E 27A, AS DESCRIBED IN THAT CERTAIN TRUSTEE'S DEED OF DISTRIBUTION, IN INSTRUMENT NO.

THE SOUTH LINE WAS ESTABLISHED BY HOLDING THE SOUTH LINE OF NORTHEAST QUARTER OF SECTION 27 FROM THE FOUND BRASS CAP LOCATED AT THE EAST QUARTER CORNER OF SECTION 27 AND A FOUND %" REBAR WITH ALUMINUM CAP AT THE SOUTHEAST CORNER OF LOT 1 OF THE JOHN WEBER BUSINESS PARK, FILED AS COUNTY SURVEY NO. 90035 AND EXCEPTING THERE FROM THAT PORTION OF TAX LOT 1700 DESCRIBED IN BOOK 28, PAGE 373 AND BOOK 33, PAGE 361, HOOD RIVER COUNTY DEED RECORDS. THE OLD POSITION OF THE EAST QUARTER CORNER OF SECTION 27 WAS USED FOR THE POINT OF BEGINNING OF TAX LOT 1700. THE DEED WAS CONVEYED DURING THE 1940, BEING THE TIME PERIOD WHEN THE OLD POSITION OF THE EAST QUARTER CORNER WAS IN USE, WHICH FIT THE EXISTING FENCE LINES BETWEEN SAID TAX LOT 1600 AND 1700.

THE WEST LINE WAS ESTABLISHED BY HOLDING THE EASTERLY LINE OF LOT 1 OF JOHN WEBER BUSINESS PARK.

THE NORTH LINE WAS ESTABLISHED BY HOLDING THE DEED CALL OF 207.9 FEET NORTHERLY AND PARALLEL WITH THE SOUTH LINE OF THE NORTHEAST QUARTER OF SECTION 27.

THE EASTERLY LINE WAS ESTABLISHED BY HOLDING THE WESTERLY RIGHT-OF-WAY AS PER NOTE 4.

NOTES:

- FOUND HOOD RIVER COUNTY BRASS CAP IN MONUMENT CASE FOR THE EAST QUARTER CORNER OF SECTION 27, AS PER CORNER CARD NO. 544. SAID QUARTER CORNER WAS REPOSITIONED ON NOV. 22. 1989 AS PER HOOD RIVER COUNTY SURVEYOR OFFICE, SAID QUARTER CORNER WAS RESET SET BY FOUND EVIDENCE FROM MONUMENTS DISCOVERED BY DLC SURVEYING WHICH WERE ORIGINALLY SET IN COUNTY SURVEY NO. 0535 BY A.R. CRUIKSHAN. THE OLD POSITION OF THE EAST QUARTER CORNER WAS 17.5 FEET EAST OF NEW POSITION AS SET BY HOOD RIVER COUNTY. SAID NEW POSITION OF THE EAST QUARTER CORNER FALLS ON THE WESTERLY EDGE OF THE EXISTING PAVED ROAD.
