



THE LEGAL DESCRIPTIONS FOR THE TRACT OF LAND BEING SURVEYED AND THOSE TRACTS OF LAND LOCATED WEST OF AND EAST THE TRACT BEING SURVEYED ARE DESCRIBED AS FOLLOWS:

COMMENCING AT A POINT ON THE EAST BOUNDARY LINE OF SECTION 22, TOWNSHIP 2 NORTH, RANGE 10 EAST OF THE WILLAMETTE MERIDIAN, IN HOOD RIVER COUNTY, STATE OF OREGON, WHICH IS THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF SAID SECTION 22: THENCE WEST ON THE SOUTH LINE OF THE NORTHEAST QUARTER OF SAID SECTION 22 TO ITS INTERSECTION WITH THE WESTERLY RIGHT OF WAY LINE OF STATE HIGHWAY 282, ALSO KNOWN AS ODELL HIGHWAY ...; THENCE CONTINUING WEST ON THE SOUTH LINE OF THE NORTHEAST QUARTER OF SAID SECTION 22 A DISTANCE OF 830 FEET, ...; THENCE NORTH AND PARALLEL WITH THE EAST LINE OF SAID SECTION 22, 332 FEET TO A POINT ...

FOR THE TRACTS TO THE WEST, .. ; THENCE WEST AND PARALLEL WITH THE SOUTH LINE OF THE NORTHEAST QUARTER ...

2004 AND ARE NOT SHOWN IN COUNTY SURVEY NO. 2004-049.

FOR THE TRACT TO THE EAST,...; THENCE EAST AND PARALLEL WITH THE SOUTH LINE OF THE NORTHEAST QUARTER OF SAID SECTION 22, 480 FEET, MORE OR LESS, TO THE WESTERLY RIGHT OF WAY LINE OF STATE HIGHWAY 282;

A SURVEY BY GLENN STRAIT FILED AS CS NO. 1411 CALLS FOR SETTING A REFERENCE MONUMENT PIPE AT 30.00 FEET SOUTH OF THE NORTHEAST CORNER OF THE TRACT BEING SURVEYED. SAID STRAIT SURVEY DOES NOT CALL FOR AN EXISTING PIPE AT SAID NORTHEAST CORNER, NOR DOES IT CALL FOR SETTING A PIPE AT THE NORTHEAST CORNER.

DURING THIS SURVEY THE PIPES WERE ANALYZED AND USED TO PERFORM ADDITIONAL MONUMENT SEARCHES TO VERIFY IF THE FOUND PIPES WERE PER SAID STRAIT SURVEY. MONUMENTS WERE SEARCHED WEST AND EAST OF THE FOUND PIPES USING THE RECORD DISTANCES PER SAID STRAIT SURVEY AND THE COMPUTED POSITION PER THIS SURVEY. NO ADDITIONAL MONUMENTS WERE RECOVERED, THEREFORE WE COULD NOT VERIFY THE ORIGIN AND VALIDITY OF THE FOUND PIPES.

OCCUPATION LINES INCLUDING FENCE LINES AND OTHER IMPROVEMENTS WEST OF THE NORTHEAST CORNER OF THE TRACT BEING SURVEYED WERE LOCATED. SAID OCCUPATION LINES MATCHED THE COMPUTED POSITION OF THE NORTHEAST CORNER ESTABLISHED BY

SAID PIPES WERE NOT HELD IN THIS SURVEY BECAUSE WE COULD NOT VERIFY THE ORIGIN OF THE PIPES AND THEIR LOCATIONS DID NOT AGREE WITH THE DEEDED LEGAL DESCRIPTIONS OR OCCUPATION LINES WEST OF THE PIPE LOCATIONS. SAID LEGAL DESCRIPTIONS CALL THE EAST LINE AS BEING "PARALLEL WITH THE EAST LINE OF SAID SECTION 22..." SAID PIPES WERE FOUND TO BE OVER 12 FEET WEST OF THE LINE WHICH IS PARALLEL WITH THE EAST SECTION LINE.

THE DEED FOR THE TRACT TO THE EAST SHOWS A DISTANCE CALL OF 480 FEET MORE OR LESS, TO THE WEST RIGHT OF WAY LINE OF STATE HIGHWAY 282. SAID 480 FEET CLOSELY MATCHES THE LOCATION OF THE FOUND PIPES. BUT THE MORE OR LESS CALL IS SUBSERVIENT TO THE CALL OF "NORTH AND PARALLEL WITH THE EAST LINE OF SAID SECTION 22"

NOTE: THE TRACT OF LAND TO THE EAST MAY HAVE UNWRITTEN TITLE, ADVERSE POSSESSION, ESTOPPEL OR ACQUIESCENCE RIGHTS TO THE LAND BETWEEN THE LINE ESTABLISHED BY HOLDING THE FOUND PIPES AND THE LINE DESCRIBED BY THE DEEDS, SAID DEED LINE WAS HELD AND IS SHOWN ON THIS SURVEY.

IT IS ADVISED THAT THE AFFECTED LAND OWNERS SEEK LEGAL COUNCIL TO RESOLVE ANY MATTERS WHICH MAY ARISE FROM THE BOUNDARY OVERLAP WHICH MAY HAVE BEEN CREATED BY LOCATION OF THE FOUND PIPES AND THE DEED LINES.
