


PROPERTY BOUNDARY SURVEY

LOT 3 & THE EAST 1/2 OF LOT 4, BLOCK 6, WAUCOMA LOCATED IN THE SW 1/4 OF THE SW 1/4 OF SECTION 25, TOWNSHIP 3 NORTH, RANGE 10 EAST W.M., TAX LOT 13300, 03N-10E-25CC, CITY OF HOOD RIVER, OREGON. HOOD RIVER COUNTY SURVEYOR'S OFFICE

NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO VERIFY AND MONUMENT THE BOUNDARIES OF TAX LOT 13300, DESCRIBED BY DEED DOCUMENT No.20054457 AS LOT 3 AND THE EAST HALF OF LOT 4, BLOCK 6, WAUCOMA.

A SURVEY FILED AS C.S.#96022 ESTABLISHED THE BOUNDARIES OF THE LOTS IN BLOCK 6 AND SET OR FOUND MONUMENTS AT ALL CORNERS OF LOTS 3 AND 4 EXCEPT THE SOUTH CORNERS OF LOT 4. I FOUND ALL OF THESE MONUMENTS AND CALCULATED THE SOUTHWEST CORNER OF LOT 4 BY HOLDING THE DISTANCES SHOWN ON C.S.#96022. I THEN PROPORTIONED THE SOUTHEAST CORNER OF LOT 4 AND SPLIT THE LOT IN HALF AS PER THE DEED. THE SOUTHWEST CORNER OF THE SUBJECT TRACT FELL IN A PAVER DRIVEWAY. I SET A REFERENCE MONUMENT IN THE CONCRETE SIDEWALK ON THE EXTENSION OF THE WEST LINE AT A DISTANCE OF 4 FEET.

I DID NOT ACCEPT THE 3/4" IRON ROD FOUND NEAR THE NORTHWEST CORNER OF THE SUBJECT TRACT SET FOR C.S.#7630 AS I CONSIDER THE METHOD USED BY C.S.#96022 TO BE MORE ROBUST. IT DOES NOT APPEAR THAT ANY IMPROVEMENTS HAVE RELIED UPON THE 3/4" IRON ROD. C.S.#96022 DOES NOT SHOW THE MONUMENTS SET BY C.S.#7630.

BASIS OF BEARINGS:

BETWEEN THE MONUMENTS FOUND AT THE SOUTHWEST AND SOUTHEAST CORNERS OF LOT 9, BLOCK 6 OF WAUCOMA ADDITION AS SHOWN ON C.S.#96022.

- FOUND 5/8" IRON ROD WITH YELLOW PLASTIC CAP INSCRIBED "WYEAST SURVEYS PLS 2393" FROM C.S.#96022
- FOUND SCREW IN CONCRETE FROM C.S.#96022
- O FOUND 1/2" INSIDE DIAMETER IRON PIPE
- CALCULATED CORNER NOT FOUND OR SET


