
NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO MONUMENT THE PROPERTY BOUNDARY BETWEEN TAX LOTS 2200 & 2300 OF ASSESSORS MAP 2N-10E-09. I FOUND ALL THE CONTROLLING CORNERS OF THE NORTHWEST QUARTER OF SECTION 9 AND LAID OUT THE PROPERTY AS PER THE LEGAL DESCRIPTION FROM DEED MICROFILM No.761390 FOR TAX LOT 2200. THE MONUMENT FOUND FOR THE CENTER OF SECTION 9 HAS BEEN HELD FOR SOME PREVIOUS SURVEYS BUT NOT OTHERS. I HELD THE MONUMENT AS THE CALCULATED POSITION AS SHOWN ON C.S.#2009040 IS ONLY 1.5 FEET AWAY. USING EITHER THE FOUND MONUMENT OR THE CALCULATED POSITION FROM C.S.#2009040 WOULD RESULT IN A NEGLIGIBLE DIFFERENCE IN THE LOCATION OF THE MONUMENTS SET FOR THIS SURVEY. THERE IS A SIGNIFICANT AREA OF ENCROACHING FENCES, GARDENS AND BUILDING FROM LAND

BEING OCCUPIED BY TAX LOT 2200 OVER TAX LOT 2300. A TITLE REPORT WAS NOT PROVIDED FOR THIS SURVEY AND OTHER EASEMENTS THAT ARE NOT

LEGAL DESCRIPTION:

Beginning at the Northeast corner of the Northwest quarter of Section 9, Township 2 North, Range 10 East of the Willamette Meridian; thence South along the East line of the Northwest quarter of said Section 9 a distance of 135 feet; thence West parallel with the North line of said Section 9 a distance of 220 feet; thence North parallel with the East line of the Northwest quarter of said Section 9 a distance of 135 feet to a point in the North line of said Section 9; thence East along the North line of said Section 9 a distance of 220 feet to the place of beginning.




