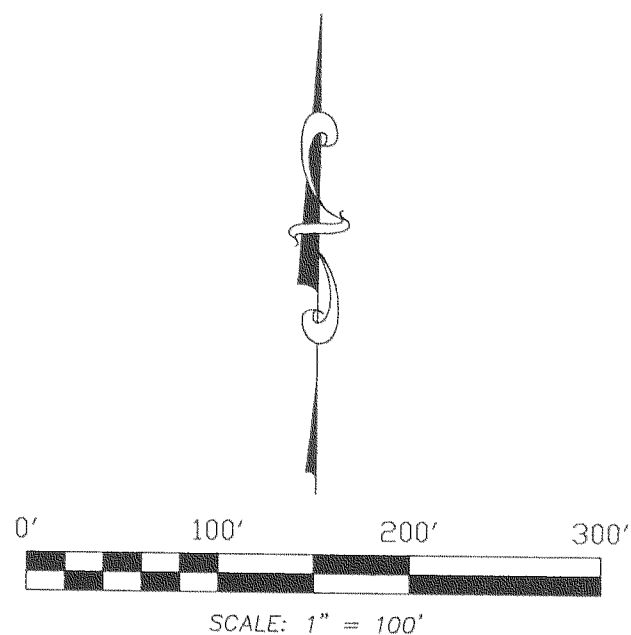

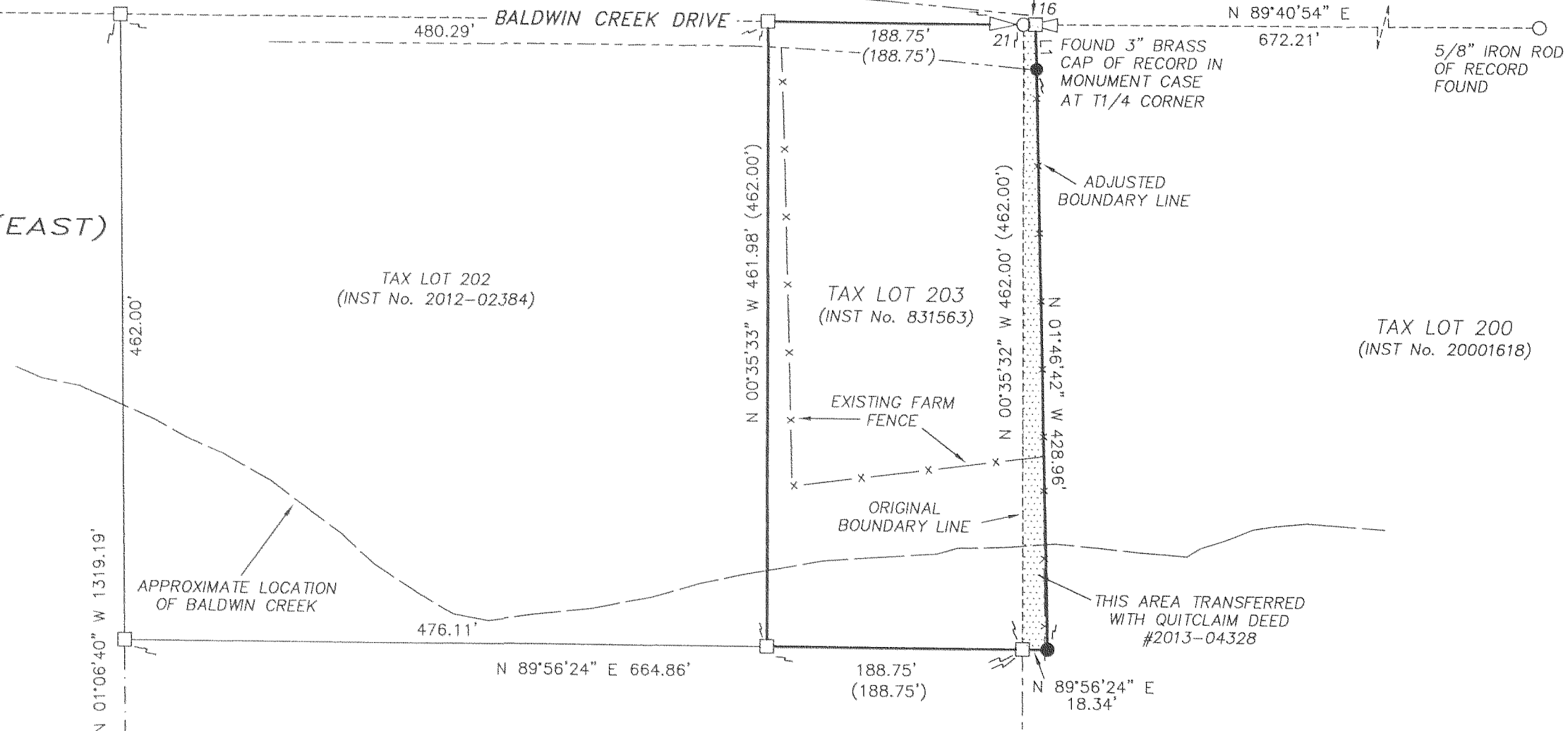
BOUNDARY LINE ADJUSTMENT SURVEY (EAST)

NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO ADJUST THE BOUNDARY LINES BETWEEN THE DEED LAYOUT POSITION AND THE LONG STANDING OCCUPATION LINES. LEGAL DESCRIPTIONS HAVE BEEN PREPARED AND LAND QUITCLAIMED BETWEEN OWNERS TO FIT THE OCCUPATION LINES. THIS ACTION HAS BEEN FOLLOWED BY MONUMENTING FENCE LINE POSITION AND FILING THIS SURVEY FOR THE EAST BOUNDARY LINE ADJUSTMENT. THE BOUNDARY WAS DESCRIBED AS A 188.75' X 462' TRACT PARALLEL TO THE NORTH LINE OF THE SECTION AND WEST A DISTANCE OF 188.75' FROM THE EAST 660 FEET, WHICH IS INTENDED TO BE MEASURED FROM THE CENTER QUARTER SECTION LINE. THE FENCE LINE ON THE EAST HAS BEEN IN PLACE FOR A VERY LONG TIME, IT IS UNCLEAR WHY THIS HISTORIC FENCE LINE AND THE CENTER SECTION LINE DO NOT AGREE AS THE NORTH QUARTER MONUMENT IS EASILY ACCESSIBLE. THIS SITUATION WAS SHOWN ON COUNTY SURVEY #85005 BY FROST, OTHER FENCES IN THE AREA MAY ALSO NOT AGREE WITH THE DEED LINES. I WILL BE FILING A SIMILAR SURVEY FOR A BOUNDARY LINE ADJUSTMENT ON THE WEST LINE TO MATCH EXISTING FENCE LINE ON THE WEST.

MONUMENTATION FOUND IN THE FIELD HAS BEEN NOTED ON THE PLAT.
