



## NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO FILE FOR RECORD AND TO MONUMENT A PROPERTY LINE ADJUSTMENT BETWEEN TAX LOTS 100 AND 400 OF ASSESSOR'S MAP 3N 10E 27C. TAX LOT 100 IS DESCRIBED IN DEEDS RECORDED AS DOCUMENT NO.'S 831160, 860275 AND 893220. TAX LOT 400 IS DESCRIBED IN DEEDS RECORDED AS DOCUMENT NO.'S 2013-00011 AND 2013-03622. THE EXISTING LINES AFFECTED BY THE ADJUSTMENT WERE ESTABLISHED AS FOLLOWS: AN IRON PIPE FOUND AT THE SOUTHEAST CORNER OF TAX LOT 100 TOGETHER WITH AN IRON ROD FOUND AT THE SOUTHEAST CORNER OF PARCEL 2 OF PARTITION PLAT 200309-P WERE HELD TO ESTABLISH THE NORTH RIGHT OF WAY LINE OF WESTCLIFF DRIVE. THE WEST LINES OF THAT TRACT OF LAND DESCRIBED IN DOC. NO. 831160 WERE ESTABLISHED AS PER THE RESOLUTION OF CS 86008 USING FOUND MONUMENTS AND RECORD DATA. THE ADJUSTED LINES WERE ESTABLISHED AS PER CLIENT INSTRUCTION. THE SOUTHEASTERLY ADJUSTED LINES WERE ESTABLISHED TO CREATE A 20 FOOT WIDE STRIP FROM WESTCLIFF DRIVE TO THE REMAINDER OF TAX LOT 400. THIS IS THE SECOND IN A SERIES OF TWO SEQUENTIAL PROPERTY LINE ADJUSTMENTS. THE RECORD OF SURVEY OF THE FIRST ADJUSTMENT WAS FILED AS CS 2013043. THE DEED DESCRIBING THE ADJUSTED PROPERTY OF THE FIRST ADJUSTMENT WAS RECORDED AS DOC. NO. 2013-03622.
