I, ERIK M. CARLSON, REGISTERED LAND SURVEYOR FOR THE STATE OF OREGON, BEING FIRST DULY SWORN, DEPOSED AND SAY THAT I HAVE CORRECTLY SURVEYED THE PROPERTY DESCRIBED IN THE LEGAL DESCRIPTION AND MARKED WITH LEGAL MONUMENTS THE LAND REPRESENTED ON THE PLAT OF "MOUNTAIN VISTAS—PHASE 1" HOOD RIVER COUNTY, STATE OF OREGON. NARRATIVE:

THE PURPOSE OF THIS SURVEY WAS TO PLAT TAX LOT 200 WHICH IS A PORTION OF PARCEL 1 HOOD RIVER COUNTY PARTITION PLAT No. 2003—10P AS RECORDED IN HOOD RIVER COUNTY RECORDS, PARCEL 1 CONTAINED 29.96 ACRES MORE OR LESS. THIS LARGE TRACT WAS SHOWN AS "UNSURVEYED" DUE TO THE SIZE OF THE TRACT BEING OVER 10 ACRES. THIS TRACT WAS ORIGINALLY DESCRIBED IN DEED TO SIEVERKROPP ORCHARDS, INC FROM JOHN SIEVERKROPP INST#800749, THIS DEED INCLUDED THE MAJORITY OF THE DEVELOPED AND UNDEVELOPED LAND FROM 8TH STREET EASTERLY TO A LINE 100 WEST OF THE WEST BANK OF THE HOOD RIVER. PREVIOUS TO THE 2003 PARTITION PLAT, THIS LAND WAS PARTITIONED IN 1999 CREATING A 38.96 ACRE TRACT CALLED PARCEL 3 OF PARTITION PLAT No. 9914. THAT PARCEL WAS SUBDIVIDED AND FURTHER BROKEN DOWN INTO MORE RESIDENTIAL LOTS IN THE ELIOT PARK SUBDIVISION, PHASES 1 THROUGH 4. WE WERE ABLE TO TIE INTO RECORD MONUMENTS FROM ALL THE SURROUNDING DEVELOPMENTS TO CREATE CONTINUITY BETWEEN EARLY DEVELOPMENT AND CURRENT.

IN THE FIELD, THE BASIS OF BEARING FOR THIS PLAT WAS MEASURED BETWEEN TWO ALUMINUM CAPS FOUND IN THE CENTERLINE OF PACIFIC AVENUE AT THE INTERSECTIONS OF 4TH STREET AND 5TH STREET. THESE MONUMENTS WERE ORIGINALLY SET ON PHASE TWO OF PACIFIC HEIGHTS SUBDIVISION (C.S.2001–068) COMPLETED IN 2001 BY WYEAST SURVEYS. THIS BASELINE WAS USED TO CALCULATE ALL OF THE SEARCH POSITIONS FOR THE OUTBOUNDS OF PHASE ONE OF THIS PLAT. NEARLY EVERY SEARCH POSITION LANDED ON A CONSTRUCTED FENCE LINE FROM PREVIOUSLY PLATTED SUBDIVISIONS, MOST OF WHICH THE LOT CORNER MONUMENT WAS DESTROYED. WE DID TIE INTO SEVERAL MONUMENTS WHICH WERE PRESERVED BY THE FENCE BUILDER, THESE MONUMENTS FIT VERY WELL WITH THE RECORD DISTANCES. ON THE UNDEVELOPED SIDE OF THIS PHASE IS THE REMAINDER OF TAX LOT 200, THIS LAND HAS BEEN APPROVED FOR FUTURE PHASES OF MOUNTAIN VISTAS.
