

#### **NARRATIVE**

THE PURPOSE OF THIS SURVEY IS TO POST, FLAG AND BLAZE THE HOOD RIVER COUNTY FORESTRY BOUNDARY AS SHOWN ON THIS SURVEY.

THE 1/16 LINE RUNNING NORTH FROM THE E 1/16 COMMON TO SECTIONS 7 AND 18 TO THE SE 1/16 CORNER WAS ESTABLISHED BY HOLDING 1/2" IRON PIPES ESTABLISHED IN THE MARION MACRAE TRACTS, SURVEY NO.-0930.

THE EAST LINE OF SECTION 7 WAS ESTABLISHED BY HOLDING THE SE CORNER OF SECTION 7 AND A 1/2" IRON PIPE FOR THE 1/4 CORNER COMMON TO SECTIONS 7 AND 8. SEE NOTE 1 BELOW.

THE LINE RUNNING EAST FROM THE SE 1/16 CORNER WAS ESTABLISHED BY HOLDING THE 1/2" IRON PIPE AT THE SE 1/16 CORNER AND A COMPUTED POSITION FOR THE S 1/16 CORNER COMMON TO SECTIONS 7 AND 8.

THE LINE RUNNING WEST FROM THE N-S 1/64 CORNER COMMON TO SECTIONS 7 AND 8 WAS ESTABLISHED BY HOLDING A 1/2" IRON PIPE AS DESCRIBED IN NOTE 2 AND RUNNING WEST TO A 1/2" IRON PIPE AT THE C-N-SE 1/64 CORNER.

THE SOUTH EAST CORNER OF THE FORESTRY PROPERTY LOCATED EAST 524.09' FROM THE SE 1/16 CORNER THENCE RUNNING NORTH 22\*45'40" EAST, 715.89' WAS ESTABLISHED BY HOLDING DEED CALLS FROM THE EAST LINE OF SECTION 7 AND AS DESCRIBED IN PARCEL 4 OF WARRANTY DEED DOCUMENT NO. 660530.
