

NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO REESTABLISH AND MONUMENT THE PROPERTY BOUNDARY OF TAX LOT 4200 AS DESCRIBED BY DEED DOCUMENT No. 2013-02313.

THE PROPERTY IS DESCRIBED AS THE SOUTH HALF OF LOT 6 OF BLOCK 1 OF MOUNTAIN VIEW ADDITION, EXCEPTING THEREFROM THOSE PORTIONS CONVEYED TO THE CITY OF HOOD RIVER BY DEED BOOK 38, PAGE 162. DEED BOOK 38, PAGE 162 INCLUDES CONVEYANCES OF THAT PORTION OF LOT 6 INCLUDED IN THE STRIP OF LAND 25 FEET EAST OF THE EAST LINE OF LOT 14 OF ADAMS PARADISE ACRES, THE SOUTHERLY 10 FEET OF LOT 6, NORTHERLY 10 FEET OF LOT 6 AND A 20 FOOT WIDE STRIP CENTERED ON THE LINE MIDWAY BETWEEN THE NORTH AND SOUTH LINES OF LOT 6.

PARTITION PLAT 99-07, C.S.#99040, CREATED THE PARCELS TO THE EAST OF THE SUBJECT TRACT. THAT SURVEY ESTABLISHED THE LOCATION OF THE ORIGINAL LOTS 5 & 6 OF MOUNTAIN VIEW ADDITION. I HELD THE DISTANCES AS PER C.S.#99040 FROM THE IRON PIPE FOUND ON THE WEST LINE OF LOT 7 AND THE 1/2" IRON ROD SET FOR C.S.#73003 FOUND NEAR THE NORTHEAST CORNER OF LOT 5 TO ESTABLISH THE NORTHWEST CORNER OF TAX LOT 4100. I THEN HELD THE DISTANCES ALONG THE WEST LINE OF LOT 6 AS PER C.S.#99040 TO ESTABLISH THE NORTHWEST AND SOUTHWEST CORNERS OF THE SOUTHERLY PORTION OF LOT 6 WITH THE NORTHERLY & SOUTHERLY 10 FEET EXCLUDED FOR THE CITY CONVEYANCE FROM DEED BOOK 38, PAGE 162.

I HELD 25 FEET FROM THE IRON ROD FOUND FROM C.S.#93057 AT THE NORTHWEST RIGHT OF WAY CORNER OF PROSPECT AND 20TH STREET AND THE BRASS CAP FOUND TO THE NORTH TO ESTABLISH THE EAST LINE OF LOT 14 OF ADAMS PARADISE ACRES. I THEN OFFSET THIS LINE BY THE 25 FOOT DISTANCE CALLED IN DEED BOOK 38, PAGE 162 TO ESTABLISH THE WESTERLY LINE OF THE SUBJECT TRACT.

I HELD THE MONUMENT FOUND FROM C.S.#99040 AT THE NORTHWEST CORNER OF PARTITION PLAT 99-07 FOR THE NORTHEAST CORNER OF THE SUBJECT TRACT. THE SOUTHWEST CORNER OF PARTITION PLAT 99-07 HAS BEEN DESTROYED BY RECENT CONSTRUCTION WORK. I HELD THE RIGHT OF WAY DISTANCE FROM THE IRON PIPE FOUND ON THE SOUTH LINE OF PROSPECT AVENUE AND PROPORTIONED THE DISTANCES AS PER C.S.#99040 ALONG THE NORTHERLY LINE OF PROSPECT AVENUE BETWEEN THE RAIL SPIKE FOUND AT THE SOUTHEAST CORNER OF PARTITION PLAT 9907 AND THE SOUTHWEST CORNER OF THE SUBJECT TRACT.

I COULD NOT SET THE SOUTHEAST CORNER OF THE SUBJECT TRACT DIRECTLY AS IT FELL OVER UTILITIES. A REFERENCE MONUMENT WAS SET IN THE SIDEWALK ON THE 8 FOOT EXTENSION OF THE EASTERLY LINE.




