

TRACT 1

A public right of way for road and utility purposes located in the northeast quarter of Section 5, Township 1 South, Range 10 East, of the Willamette Meridian in the County of Hood River and State of Oregon being that portion of Parcel 1 of Partition Plat 9820 included in a 60.00 foot wide strip of land being 30.00 feet on each side of the following described centerline:

Beginning at a point on the west line of the southeast quarter of the northeast quarter of said Section 5 that bears South 00°24'42" East, a distance of 517.46 feet from the northwest corner thereof; thence along a 1493.50 foot radius curve to the right, through a central angle of 11°29'10" (chord bears North 03°41'04" West, 298.90 feet) an arc distance of 299.40 feet to a point of compound curvature; thence along a 229.35 foot radius curve to the right, through a central angle of 58°50'14" (chord bears North 31°28'38" East, 225.31 feet) an arc distance of 235.52 feet; thence North 60°53'45" East, a distance of 196.91 feet; thence along a 2554.66 foot radius curve to the left, through a central angle of 12°27'24" (chord bears North 54°40'03" East, 554.31 feet) an arc distance of 555.41 feet. Containing 13,696 square feet, more or less.

TRACT 2

A 50.00 foot wide public right of way for road and utility purposes located in the northeast quarter of Section 5, Township 1 South, Range 10 East, of the Willamette Meridian in the County of Hood River and State of Oregon being 25.00 feet on each side of the following described center line:

Beginning at a point on the north line of Parcel 1 of Partition Plat 9820 that bears North 89°01'30" East, a distance of 517.89 feet from the northwest corner thereof; said point being at the intersection of said north line with the center line of a 50.00 foot wide easement for ingress, egress and utilities created and granted by said plat; thence along said center line, South 06°42'05" East, a distance of 75.66 feet; thence South 10°26'09" West, a distance of 165.99 feet to the south line of said Parcel 1. The sidelines of said 50 foot easement to be extended or shortened to terminate at the north and south lines of said Parcel 1. Containing 12,082 square feet, more or less.

TRACT 3

A 50.00 foot wide public right of way for road and utility purposes located in the northeast quarter of Section 5, Township 1 South, Range 10 East, of the Willamette Meridian in the County of Hood River and State of Oregon being 25.00 feet on each side of the following described center line:

Beginning at a point on the north line of Parcel 1 of Partition Plat 9820 that bears North 89'01'30" East, a distance of 517.89 feet from the northwest corner thereof; said point being at the intersection of said north line with the center line of a 50.00 foot wide easement for ingress, egress and utilities created and granted by said plat; thence North 06'42'05" West, a distance of 95.18 feet; thence North 37'06'20" West, a distance of 62.14 feet to the southeasterly right of way line of Tollbridge Road. The sidelines of said 50 foot easement to be extended or shortened to terminate at the north line of said Parcel 1 and the southeasterly right of way line of Tollbridge Road. Containing 7,868 square feet, more or less.

NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO SURVEY AND MONUMENT THREE TRACTS
OF LAND BEING OFFERED FOR DEDICATION AS A PUBLIC RIGHT OF WAY PURSUANT
TO O.R.S. 368.106. THE FIRST TRACT BEING OFFERED FOR DEDICATION IS THAT PORTION
OF TOLLBRIDGE ROAD LYING WITHIN THE BOUNDARIES OF PARCEL 1 OF PARTITION PLAT 9820.
A CENTER LINE ALIGNMENT FOR TOLLBRIDGE ROAD WAS DEVELOPED BASED ON THE
AS CONSTRUCTED LOCATION OF THE ROAD. THE RIGHT OF WAY IS ESTABLISHED 30 FEET
ON EACH SIDE OF THE CENTER LINE ALIGNMENT. MONUMENTS WERE RECOVERED FROM CS 98052.
TO ESTABLISH THE BOUNDARIES OF SAID PARCEL 1. THE SECOND AND THIRD TRACTS BEING OFFERED
FOR DEDICATION ARE 50 FOOT WIDE STRIPS OF LAND BEING 25 FEET ON EACH SIDE OF
THE AS CONSTRUCTED CENTER LINE OF AN EXISTING ROADWAY.
TRACT 2 IS ACROSS PARCEL 1 IN THE SAME LOCATION AS EXISTING PRIVATE EASEMENTS
CREATED AND GRANTED BY PARTITION PLAT 9820.
TRACT 3 IS ACROSS HOOD RIVER COUNTY OWNED LAND LYING NORTH OF THE NORTH LINE
OF PARCEL 1 AND SOUTH OF TOLLBRIDGE ROAD.. THE LOCATION OF THE SECOND AND THIRD TRACTS
HAD BEEN PREVIOUSLY ESTABLISHED BY PARTITION PLAT 9820.
