

# SURVEYOR'S CERTIFICATE

I, KEVIN DOWD, REGISTERED PROFESSIONAL LAND SURVEYOR FOR THE STATE OF OREGON, SAY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LAND REPRESENTED ON THIS PLAT LOCATED IN THE SOUTHEAST QUARTER OF SECTION 15, TOWNSHIP 1 NORTH, RANGE 10 EAST OF THE WILLAMETTE MERIDIAN, IN THE COUNTY OF HOOD RIVER AND STATE OF OREGON; AND THAT A 5/8" IRON ROD WITH YELLOW PLASTIC CAP MARKED "WYEAST LS 2393" FOUND AT THE NORTHWEST CORNER OF PARCEL 3 OF PARTITION PLAT 201517P IS THE INITIAL POINT OF THIS PLAT; AND THAT THE LANDS REPRESENTED ON THIS PLAT ARE MORE PARTICULARLY DESCRIBED AS FOLLOWS:

PARCEL 3 OF PARTITION PLAT 201517P, RECORDED DECEMBER 17, 2015, HOOD RIVER COUNTY PLAT RECORDS.

## **EASEMENTS**

EASEMENT FOR ROAD, 1 ROD WIDE, ALONG SOUTH SIDE OF GOVERNMENT LOT 10 RESERVED IN DEED, RECORDED MARCH 12, 1906 IN BOOK H AT PAGE 198. (AND AS PER OTHER DEEDS)
THIS EASEMENT IS LOCATED IN NEWTON DRIVE, A PUBLIC RIGHT OF WAY, AS IT CROSSES PARCEL 3.

AN EASEMENT FOR ELECTRIC TRANSMISSION AND DISTRIBUTING LINE AND APPURTENANCES GRANTED PACIFIC POWER AND LIGHT COMPANY BY EASEMENT DEED RECORDED JUNE 27, 1912 IN BOOK 7 AT PAGES 231 AND 232. AFFECTS GOVERMENT LOT 10 IN SECTION 15. THE GENERAL LOCATION IS DESCRIBED TO BE ABOUT 18 FEET EAST OF THE WEST LINE OF SAID LOT 10.

A RIGHT OF WAY FOR ROAD GRANTED TO THE COUNTY OF HOOD RIVER BY RIGHT OF WAY DEED RECORDED NOVEMBER 12, 1921 IN DEED BOOK 15, PAGE 583. RIGHT OF WAY IS 60 FEET WIDE ACROSS THE LANDS OF LOUIS NEX IN THE SOUTHEAST QUARTER OF SECTION 15. I ESTABLISHED THE RIGHT OF WAY AS PER THE ALIGNMENT DATA OF O.D.O.T. MAP 2B-17-13 AS SHOWN ON MAP.

AN EASEMENT IN FAVOR OF CRYSTAL SPRINGS WATER DISTRICT
AS PER CIRCUIT COURT JUDGMENT NO. 5974 ENTERED JANUARY 25, 1968.
THE EASEMENT IS 20 FEET WIDE AND THE JUDGMENT PROVIDES A METES AND
BOUNDS DESCRIPTION OF IT'S LOCATION. THE LOCATION AS SHOWN ON THE MAP
IS BASED ON FIELD TIES TO THE RIGHT OF WAY CLEARING. I FELT THAT THIS
MORE ACCURATERLY DEPICTS THE EASEMENT LOCATION. IF THE LOCATION IS
IN DOUBT, CALL FOR A LOCATE.

CONVEYANCE OF ACCESS RIGHTS CONVEYED AND RELINQUISHED TO THE STATE OF OREGON, BY AND THROUGH IT'S STATE HIGHWAY COMMISSION RECORDED AUGUST 6, 1990 AS DOCUMENT NO. 902105. THIS DOCUMENT LIMITS ACCESS TO THE RELOCATED MT. HOOD HIGHWAY.

AGREEMENT FOR BOUNDARY CLARIFICATION, RESTRICTIVE COVENANT AND WATERLINE EASEMENT RECORDED SEPTEMBER 25, 2006 AS DOCUMENT NO. 20064686. THIS DOCUMENT ESTABLISHED THE NORTH LINE OF PARTITION PLAT 200632P BY AGREEMENT. THE DOCUMENT ALSO GRANTED AN 8 FOOT WIDE EASEMENT FOR AN IRRIGATION WATERLINE FOR THE BENEFIT OF SAID PARTITION PLAT PARCELS. THE APPROXIMATE LOCATION OF THE EASEMENT AS SHOWN ON MAP.

NEWTON DRIVE AND BURL ROAD, PUBLIC RIGHTS OF WAY FOR ROAD AND UTILITY PURPOSES AS DEDICATED PER PARTITION PLAT 200632P.
SUBJECT TO ROAD MAINTENANCE AGREEMENT RECORDED DECEMBER 28, 2006 AS DOCUMENT NO. 2006-06218. THE PARCELS CREATED BY THIS PARTITION ARE SUBJECT TO AND BENEFIT FROM SAID AGREEMENT. THE LOCATION OF NEWTON DRIVE AND BURL ROAD ARE AS SHOWN ON MAP.



## NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO PARTITION PARCEL 3 OF PARTITION PLAT 201517P INTO THREE PARCELS. MONUMENTS WERE RECOVERED FROM SAID PLAT TO ESTABLISH THE EXTERIOR BOUNDARIES OF PARCEL 3. THE PARCEL LINES BEING CREATED WERE ESTABLISHED AS PER CLIENT INSTRUCTION. PARCEL 2 BEING CREATED IS UNDER 2.5 ACRES IN AREA AS PER AN APPROVED VARIANCE. THIS IS THE FINAL PLAT OF A SERIES PARTITION OF A 17.5 ACRE PARENT TRACT. SEE PARTITION PLATS 200632P AND 201517P FOR ADDITIONAL DETAILS ON THE ESTABLISHMENT OF THE PARENT TRACT BOUNDARIES.



A PRIVATE VIEW EASEMENT/ HEIGHT RESTRICTION IS BEING CREATED BY THIS PLAT OVER PARCEL 2 FOR THE BENEFIT OF PARCEL 3. NO BUILDING OR STRUCTURE MAY BE ERECTED OR ANY TREE OR VEGETATION BE ALLOWED TO GROW WITHIN THE EASEMENT AREA HIGHER THAN AN ELEVATION OF 1546.5'. THIS EQUATES TO A HEIGHT OF APPROXIMATELY 20 FEET ABOVE A 1/2" IRON ROD WITH RED PLASTIC CAP MARKED "CONT. PT." SET FLUSH WITH THE EXISTING GROUND ELEVATION. THE LOCATION AND ELEVATION OF THE IRON ROD CONTROL POINT IS AS SHOWN ON THE DETAIL ABOVE. TRIMMING AND TOPPING OF TREES OR VEGETATION ABOVE THE ELEVATION OF 1546.5' SHALL NOT BE DONE MORE THAN ONCE PER CALENDER YEAR AND ONLY AFTER THIRTY DAYS WRITTEN NOTICE TO THE OWNER OF PARCEL 2. THE TRIMMING AND TOPPING SHALL BE AT THE SOLE EXPENSE OF THE OWNER OF PARCEL 3, WHO SHALL FURTHER BE RESPONSIBLE FOR REMOVAL OF THE DEBRIS ASSOCIATED THEREWITH.
