
RIGHT OF WAY SURVEY

NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO MONUMENT THE RIGHT OF WAY OF AGA ROAD WHICH WAS LEGALIZED APRIL 17, 2017, BY HOOD RIVER COUNTY COMMISSIONERS ORDER 17-004. PURSUANT TO COUNTY COMMISSIONERS RESOLUTION No. 2081, DATED FEBRUARY 16, 2016, THE HOOD RIVER COUNTY SURVEYOR LOCATED THE EXISTING ALIGNMENT OF AGA ROAD FROM ITS NORTHERLY EXTENT AT THE INTERSECTION WITH ODELL HIGHWAY AND EAGLE LOOP TO ITS SOUTHERLY EXTENT AT THE

AGA ROAD IS BEING LEGALIZED TO CORRESPOND WITH THE LOCATION AS THE RIGHT OF WAY IS SHOWN IN THE SURVEYS OF RECORD DATING BACK TO AT LEAST 1909 FOR C.S.#514 BY THE THEN COUNTY SURVEYOR JOHN LEYLAND HENDERSON. THE ROADWAY HAS FOR MANY YEARS FOLLOWED THE WEST LINE OF PLOG-DAVIS ADDITION TO THE WEST 1/4 CORNER OF SECTION 26 AND THEN SOUTHERLY ALONG THE SECTION LINE TO THE 1/16 CORNER AT DAVIS DRIVE.

AGA ROAD WAS ORIGINALLY ESTABLISHED AS A 60 FOOT WIDE RIGHT OF WAY BY WASCO COUNTY ROAD BOOK 1 IN 1880 IN A LOCATION APPROXIMATELY 100 FEET TO THE EAST OF THE LOCATION AS PRESENTLY CONSTRUCTED AND TRAVELED. IT DOES NOT APPEAR TO HAVE EVER BEEN CONSTRUCTED IN THIS LOCATION. NO SURVEYS WERE FOUND THAT SHOW A LOCATION FOR THE RIGHT OF WAY AS DESCRIBED BY WASCO COUNTY ROAD BOOK 1

IN 1989 IT WAS DISCOVERED THAT THE WEST 1/4 CORNER OF SECTION 26 WAS MONUMENTED 17.5 FEET TO THE EAST OF THE CORRECT LOCATION. IT APPEARS IT WAS MOVED SOME TIME BETWEEN THE PLAT OF THE FIRST ADDITION TO ODELL AND PLOG-DAVIS ADDITION. THIS FACT CAN BE ATTRIBUTED TO THE DIFFERENCE IN THE CALL ALONG THE CENTER SECTION LINE FROM THE 1/4 CORNER. THE FIRST ADDITION TO ODELL DEDICATED IN 1924 CALLS 804 FEET. HIGHWAY DEPARTMENT DRAWING 05F-08-08 DATED 1942, SHOWS A STONE FOUND AT THE 1/4 CORNER, REPLACED WITH A IRON PIPE AND ALSO SHOWS 804.0' TO THE WEST LINE OF THE FIRST ADDITION TO ODELL, A SUBSEQUENT SURVEY, C.S. #519 FROM 1944 ALSO MEASURES 804 FEET TO THE WEST LINE OF THE FIRST ADDITION TO ODELL. IN 1946 THE PLAT OF PLOG-DAVIS ADDITION SHOWS THE SAME DISTANCED TO NOW BE 786.5 FEET, A DIFFERENCE OF 17.5 FEET, AS THE PLAT OF PLOG-DAVIS ADDITION CALLS TO THE WEST LINE OF THE FIRST ADDITION TO ODELL THERE IS NO GAP CREATED. AGA ROAD IS CURRENTLY CONSTRUCTED IN THE LOCATION AS SHOWN ON THE PLAT OF PLOG-DAVIS ADDITION, WITH THE CENTER OF THE CONSTRUCTED ROADWAY VERY NEAR THE ERRONEOUS 1/4 CORNER LOCATION. FOR THIS REASON THE RIGHT OF WAY IS BEING LEGALIZED FROM THE NW CORNER OF PLOG-DAVIS ADDITION SOUTHERLY TO A POINT 17.5 FEET EAST OF THE CORRECTLY MONUMENTED 1/4 CORNER, THENCE CONTINUING SOUTHERLY TO THE SOUTHEAST CORNER OF PARCEL 1 OF PARTITION PLAT 9904 BEING A POINT VERY CLOSE TO WHERE THE CENTER OF THE CONSTRUCTED ROADWAY INTERSECTS THE SECTION LINE AND THEN CONTINUING SOUTHERLY TO THE 1/16TH CORNER AT DAVIS DRIVE.

MONUMENTS WERE FOUND AS PER C.S.#2011025 NEAR THE WEST RIGHT OF WAY OF AGA ROAD. I HELD THE MONUMENT FOUND AT THE SOUTHERLY TANGENT AT THE INTERSECTION WITH EAGLE LOOP AS CREATED ON THE PLAT OF JOHN WEBBER BUSINESS PARK, FROM THIS POINT I HELD 30 FEET TO ESTABLISH THE WEST LINE OF PLOG-DAVIS ADDITION. I THEN EXTENDED THE WEST LINE OF PLOG DAVIS ADDITION LINE NORTHERLY, HOLDING THE DISTANCE CALL FROM C.S#519 TO ESTABLISH THE NW CORNER OF PLOG DAVIS ADDITION. THE CENTERLINE WAS THEN HELD FROM THE NW CORNER OF PLOG DAVIS ADDITION TO A POINT ON THE CENTER SECTION LINE 17.5 FEET EAST OF THE MONUMENTED SECTION CORNER. I THEN HELD THE CENTERLINE CONTINUING SOUTHERLY TO A POINT AT THE INTERSECTION WITH THE SECTION LINE AT THE SE CORNER OF PARCEL 1 OF PARTITION PLAT 9904. THE CENTER LINE WAS THEN HELD FROM THIS POINT SOUTHERLY TO THE 1/16 CORNER





LEGAL DESCRIPTION:.

A 60 foot wide Public Right of Way located in Sections 26 & 27, Township 2 North, Range 10 East of the Willamette Meridian, Hood River County, Oregon, being 30 feet either side of the following described center line:

Beginning at the Northwest corner of Plog-Davis Addition to Odell, recorded February 25, 1946, said point being North 07°20'59" East, a distance of 416.50 feet from the West quarter corner of Section 26, Township 2 North, Range 10 East of the Willamette Meridian. thence South 04°56'50" West, a distance of 414.94 feet to a point on the center Section line of said Section 26, being South 88°58'47" East, a distance of 17.50 feet from the said West quarter corner of said Section 26; thence South 02°10'16" West, a distance of 648.21 feet to a point on the West line of said Section 26, said point being the Southeast corner of Parcel 1 of Partition Plat 9904, recoded March 17, 1999; thence South 00°37'27" West on the West line of said Section 26, a distance of 684.28 feet to the Southwest corner of the Northwest quarter of said Section 26 being the point of termination of this center line description.

Excepting therefrom any portion of the above describe Right of Way located within Odell Highway, State Highway No.282.
