- 2) 5/8" IR W/YPC "OR#932 WA#22098", SET IN (8), LEANING, DUG DOWN AND TIED AT VERTICAL POINT, 2.7' NE OF FENCE CORNER. HELD.
- (3) 1/2" IR, NO CAP, SET IN (7), S87° 45' 15"W 0.61' OF LINE.

**NARRATIVE** 

BASIS OF BEARING BETWEEN (12) AND (13) PER REFERENCE 9.

THE PURPOSE OF THIS SURVEY WAS TO LOCATE THE BOUNDARIES OF LOTS 6-9 AND 16-19 BLOCK 5 OF AMENDED PLAT OF IDLEWILDE TO ADDRESS CONCERNS REGARDING NEW CONSTRUCTION ON LOTS 8, 9, 16, AND 17.

THE OUTBOUNDS OF SAID BLOCK, WHICH CONSISTED OF 100'X50' LOTS, HAVE BEEN SHOWN IN ALL SURVEYS AFTER THE ORIGINAL PLAT TO BE SHORTER ALONG ALL FOUR SIDES AND DISTANCES WERE PRORATED AMONG THE LOTS ALONG THE NORTH AND SOUTH LINE OF SAID BLOCK.

A NEW MONUMENT WAS SET AT THE NORTHWEST CORNER OF BLOCK 5 (ALSO BEING THE NW CORNER OF LOT 13), BUT THE SURVEY DID NOT STATE THE STATUS OF THE ORIGINAL 1—INCH PIPE. SEVERAL OTHER MONUMENTS ALONG THIS LINE APPEARED DISTURBED TO SOME DEGREE, BEING EITHER BENT OR LEANING, BUT BEING THE BEST EVIDENCE OF THE ORIGINAL LOT CORNERS, WERE HELD UNLESS OTHERWISE NOTED.

THE NORTH LINE OF THE SUBJECT LOT WAS DETERMINED BY HOLDING THE RECENTLY SET MONUMENT BY TERRA SURVEYING AT THE NORTHEAST CORNER OF LOT 17 AND MONUMENT (4) AT THE NORTHWEST CORNER OF LOT 21.

THE SOUTH LINE OF THE SUBJECT TRACT WAS DETERMINED BY HOLDING MONUMENT (12), THE RECENTLY SET MONUMENT AT THE SOUTHEAST CORNER OF LOT 8, AND MONUMENT (13) AT THE SOUTHEAST CORNER OF LOT 6.

FENCES IN THE AREA APPEAR TO BE OLDER AND ONLY RELATIVELY FOLLOW THE LOT LINES. THE NORTHWEST AND NORTHEAST CORNERS OF LOT 19 ARE APPROXIMATELY 1.25' AND 2.0' RESPECTIVELY NORTH OF THE EXISTING WIRE FENCE.
