


NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO ORIGINALLY REPLAT LOTS 3 AND 4 OF BLOCK 4, PLAT OF CASCADE LOCKS, INTO TWO PARCELS. BUT, THE CLIENT HAS DECIDED NOT TO PROCEED, SO A RECORD OF SURVEY IS BEING RECORDED, TO SHOW THE LOCATION OF MONUMENTS SET FOR SAID PARTITION. THE PROPERTY IS DESCRIBED IN THAT CERTAIN STATUTORY WARRANTY DEED, CONVEYED TO NORWAY CONSTRUCTION, LLC, RECORDED AUGUST 20, 2018, IN INSTRUMENT NO. 2018–02826, HOOD RIVER COUNTY RECORDS.

A MATHEMATICAL MODEL OF BLOCK 4, WAS MADE BASED ON A SURVEY PERFORMED BY OUR FIRM, ON LOTS 5 AND 6, FILED AS COUNTY SURVEY NO. 94074. MONUMENTS WERE RECOVERED AT THE SOUTHEAST AND NORTHEAST CORNERS OF LOT 5, ALONG WITH A REFERENCE MONUMENT SET ON THE NORTH LINE OF SAID LOT 6. A 3/4" AXLE, POINT (250) WAS HELD FOR INTERSECTION OF THE CENTERLINES OF MOODY AVENUE AND VENTURE STREET, ALONG WITH A 2" AXLE, POINT (252), HELD FOR THE INTERSECTION OF THE CENTERLINE OF MOODY AVENUE AND REGULATOR STREET. A 1" IRON PIPE RECOVERED NEAR THE NORTHEAST CORNER OF LOT 5, POINT (255), WAS FOUND NORTH 55'30'00" WEST, 1.09 FEET FROM COMPUTED POSITION AND WAS NOT ACCEPTED, ALL OTHER MONUMENTS WERE FOUND WITHIN ACCEPTABLE TOLERANCES AND HELD IN THIS SURVEY. A NEW MONUMENT WAS SET AT THE COMPUTED POSITION OF THE NORTHWEST CORNER OF LOT 3. WHICH WAS BASED ON A PROPORTIONATE DISTANCE FROM A SET 5/8" REBAR, LOCATED AT THE NORTHEAST CORNER OF LOT 4 AND THE COMPUTED POSITION OF THE NORTHWEST CORNER OF LOT "B" PER COUNTY SURVEY NO. 94074. THE SOUTHWEST CORNER OF LOT 3 WAS ESTABLISHED BASED ON THE COMPUTED DISTANCE FROM A REFERENCE MONUMENT POINT (251) AS SHOWN IN COUNTY SURVEY 94074. A PROPERTY MONUMENT WAS NOT SET AT THE SOUTHWEST CORNER OF SAID LOT 3, DUE TO THE LOCATION FALLING WITHIN AN EXISTING ROCK WALL; WHICH WAS UNSTABLE AND GOING TO BE REMOVED BY THE PROPERTY OWNER AT THE TIME OF CONSTRUCTION.
