

NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO ESTABLISH THE BOUNDARIES OF THAT TRACT OF LAND DESCRIBED IN DEED RECORDED AS DOCUMENT NO. 2015-02859. THIS SURVEY IS A CONTINUATION OF A SURVEY CONDUCTED IN 2016. THE RECORD OF WHICH IS FILED AS CS 2017002. THE SURVEY WAS HALTED UPON DISCOVERY OF THE IMPROVEMENTS SHOWN ON SHEET 2. I HAVE BEEN REQUESTED TO COMPLETE THE SURVEY. THE WEST LINE IS DEFINED BY THE EAST LINE OF PARCEL 1 OF DOCUMENT NO. 720378 EXTENDED NORTHERLY TO THE SOUTH RIGHT OF WAY LINE OF THE COLUMBIA RIVER HIGHWAY. MONUMENTS WERE RECOVERED FROM CS 78084 AND CS 79057 TO ESTABLISH THE LINE. THE NORTH LINE IS DEFINED BY THE SOUTH RIGHT OF WAY LINE OF THE COLUMBIA RIVER HIGHWAY. THE ALIGNMENT DATA OF O.D.O.T. MAP 7B-4-9 WAS HELD TO ESTABLISH SAID RIGHT OF WAY. THE ALIGNMENT WAS BEST FIT TO THE FOUND RIGHT OF WAY MONUMENTS AS SHOWN. THE NORTHEAST CORNER WAS ESTABLISHED ON SAID RIGHT OF WAY LINE AT DEED DISTANCE FROM THE NORTHWEST CORNER. THE MOST NORTHERLY EAST LINE WAS ESTABLISHED BY HOLDING DEED ANGLE AND DISTANCE. DEED ANGLE WAS ALSO HELD TO ESTABLISH THE EASTERLY INTERIOR LINE. THE TRACT IS DESCRIBED AS THE WEST 450 FEET OF A LARGER PARENT TRACT. THE SOUTH 486 FEET IS ALSO EXCEPTED FROM THE LARGER TRACT. THEREFORE THE MOST SOUTHERLY EAST LINE WAS ESTABLISHED PARALLEL WITH AND 450 FEET EAST OF THE WEST LINE. THE NORTH LINE OF THE LARGER TRACT IS DEFINED BY THE SOUTH LINE OF THE NORTHWEST QUARTER OF SECTION 32. BONNEVILLE PROJECT MONUMENTS (R3) FOUND AT THE EAST AND WEST QUARTER CORNERS WERE HELD TO ESTABLISH SAID SOUTH LINE. THE SOUTH LINE OF THE SUBJECT TRACT WAS ESTABLISHED PARALLEL WITH AND 486 FEET NORTH OF SAID SOUTH LINE OF THE NORTHWEST QUARTER.
