



### **NARRATIVE**

THE PURPOSE OF THIS SURVEY IS TO MONUMENT LOT 3 BLOCK 3 GRANDVIEW ADDITION TO HOOD RIVER.

THE SOUTH 5 FEET OF BLOCK 3 AND THE NORTH 5 FEET OF BLOCK 4 WAS CONVEYED TO THE CITY OF HOOD RIVER IN RIGHT OF WAY DEED, BOOK 73, PAGE 697, ON MAY 20 1963... COUNTY SURVEY 2003063 INDICATES THAT THE SAME DOCUMENT IS FOR A 5 FOOT EASEMENT.

A SURVEY BY TERRA SURVEYING, COUNTY SURVEY 2011-039 ESTABLISHED PROPERTY CORNERS ON THE NORTHERLY LINE OF GRANDVIEW ADDITION, ALSO BEING THE NORTH LINE OF HAZEL AVENUE. TERRA'S MONUMENTS ALONG WITH A KLEIN MONUMENT, C.S. 2000-105 WERE HELD AND USED TO ESTABLISH THE RIGHT OF WAY OF HAZEL AVE.

A SURVEY BY KLEIN AND ASSOCIATES, COUNTY SURVEY 2003-063 ESTABLISHED LOT 4, BLOCK 3, GRANDVIEW ADDITION TO HOOD RIVER. MONUMENTS FROM THIS SURVEY WERE RECOVERED AND THE CALCULATED BLOCK FROM SAID C.S. 2003-063 WAS USED IN THIS SURVEY. MONUMENTS AT THE NORTHEAST AND SOUTHEAST CORNERS OF SAID LOT 4 WERE HELD AND USED FOR THE BASIS OF BEARING OF THIS SURVEY. SAID MONUMENTS DO NOT AGREE WITH THE RIGHT OF WAY SOLUTION FOR HAZEL, AND EUGENE AVENUE, BUT WERE HELD TO ESTABLISH THE NORTH-SOUTH LOT LINES OF BLOCK 3. RECORD DISTANCES PER C.S. 2003-063, WERE USED FROM THE SOUTH RIGHT OF WAY LINE OF HAZEL AVE. TO ESTABLISH THE SOUTH LINE OF BLOCK 3, AND NORTH RIGHT OF WAY OF EUGENE AVENUE.

1/2" REBARS WERE RECOVERED NEAR THE SOUTHEAST AND SOUTHWEST CORNERS OF LOT 2 BLOCK 3, NO RECORD OF THESE MONUMENTS WERE FOUND, THEY ARE SHOWN AS A REFERENCE TO THE SAME TIED REBAR IN C.S. 2003-063. THERE HAS BEEN SOME DISCUSSION THAT THESE REBAR COULD BE ORIGINAL SUBDIVISION MONUMENTS, HOWEVER THEY ARE SET NEAR THE NORTH LINE OF THE 5 FEET THAT WAS CONVEYED IN RIGHT OF WAY DEED, BOOK 73, PAGE 697, DATED MAY 20, 1963. THE SUBDIVISION OF GRANDVIEW ADDITION IS DATED NOVEMBER 6 1946. IT IS APPARENT THAT THESE REBAR WERE SET MUCH LATER THEN THE ORIGINAL SUBDIVISON AND ARE NOT ORIGINAL UNDISTURBED SUBDIVISION MONUMENTS. SEE THE FACE OF THIS SURVEY FOR DETAILS ON THE FENCE ENCROACHMENT ALONG THE WEST LINE OF LOT 3.
