THE PURPOSE OF THIS SURVEY IS TO MONUMENT THE ADJUSTED LINE AND TO FILE FOR RECORD A PROPERTY LINE ADJUSTMENT BETWEEN PARCELS 1 AND 2 AS DESCRIBED IN DEED RECORDED AS INSTRUMENT NO. 2012-03645 AND PARCEL 1 OF THOSE TRACTS DESCRIBED IN INSTRUMENT NO. 2014-00389. THIS IS THE SECOND OF TWO PROPERTY LINE ADJUSTMENTS INVOLVING TAX LOT 1300. IN THE FIRST ADJUSTMENT A PORTION OF TAX LOT 1200 WAS ADJUSTED TO TAX LOT 1300. THE RECORD OF SURVEY FOR THAT ADJUSTMENT WAS FILED AS CS 2020020. IN THIS ADJUSTMENT A TRACT EQUAL IN AREA TO THAT EXCHANGED IN THE FIRST ADJUSTMENT IS BEING ADJUSTED FROM TAX LOT 1300 TO TAX LOTS 2502/2600. THE PURPOSE OF THIS IS TO INCREASE THE SETBACK FROM THE EXISTING RESIDENCE ON TAX LOT 2600. THE BOUNDARY OF TAX LOT 1300 HAD BEEN PREVIOUSLY ESTABLISHED BY CS 2018038. THE BOUNDARY OF TAX LOT 2600 HAD BEEN PREVIOUSLY ESTABLISHED BY CS 77008. CS 2018038 USED A FOUND IRON PIPE FOR THE CENTER QUARTER CORNER POSITION. WHEREAS CS 77008 USED A CALCULATED LEGAL CENTER QUARTER POSITION. I ILLUSTRATE DIFFERENCES THAT ARISE FROM THE USE OF THE TWO DIFFERENT POSITIONS ON SHEET TWO. DIRECTION FROM THE SUBJECT PROPERTY OWNERS REGARDING THIS ADJUSTMENT WAS BASED ON CS 2018038. I ESTABLISHED THE BOUNDARIES OF TAX LOT 1300 BASED ON FOUND MONUMENTS AND RECORD DATA OF CS 2018038 AND CS 2020020. THE BOUNDARIES OF TAX LOT 2502/2600 WERE NOT ESTABLISHED BY SURVEY. THEY ARE DEPICTED BASED ON DEED CALLS AND WOODWORTH ACRES PLAT DATA. A DEED CONVEYING THE TRACT TO BE EXCHANGED WAS RECORDED APRIL 21, 2020 AS INSTRUMENT NO. 2020-01466.
