

<u>NARRATIVE</u>

THE PURPOSE OF THIS SURVEY IS TO ADJUST THE PROPERTY LINE COMMON TO TAX LOTS 2701 AS DESCRIBED IN STATUTORY WARRANTY DEED, INSTRUMENT NO. 201900273, AND TAX LOT 3100, AS DESCRIBED IN WARRANTY DEED, INSTRUMENT NO. 962357. THE ADJUST AREA IS DESCRIBED IN THAT CERTAIN BARGAIN AND SALE DEED, RECORDED JUNE 24, 2021, INSTRUMENT NO. 2021–02997.

TAX LOT 2701 IS DESCRIBED AS PARCEL 2 OF PARTITION PLAT 2018-13P, THE BOUNDARY WAS ESTABLISHED BY OUR FIRM DURING 2018 AND, FILED AS COUNTY SURVEY NUMBER 2018-041. THE EXTERIOR MONUMENTS WERE RECOVERED BY OUR FIRM, AND HELD IN THIS SURVEY.


