NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO MONUMENT A PORTION OF PARCELS 1 AND 2 AS DESCRIBED IN INSTRUMENT NO. 2020-00157. THE TRACTS ARE A PORTION OF THE NORTH HALF OF THE SOUTHEAST QUARTER OF SECTION 7. I RECOVERED THE FOUND MONUMENTS AS SHOWN TO ESTABLISH THE SOUTHEAST QUARTER. I CALCULATED 1/16TH CORNER POSITIONS AT MIDPOINT TO ESTABLISH THE NORTH HALF. THE TRACT LINES WERE ESTABLISHED PARALLEL WITH THE SOUTH AND WEST LINES OF SAID NORTH HALF AT DEED DISTANCE. THE DEED DESCRIPTION CALLS FOR THE SOUTHEAST CORNER OF PARCEL 1 TO BE 9.827 CHAINS WEST OF THE S 16TH CORNER. THIS CALL CAN BE TRACED TO DEED BOOK 2, PAGE 595. THAT DEED THEN DESCRIBES A 30 CHAIN WIDE TRACT OFF OF THE WEST END OF SAID NORTH HALF. BASED ON MY SECTION SUBDIVISION MEASUREMENTS THIS CREATES AN AMBIGUITY AS TO THE LOCATION OF. SAID SOUTHEAST CORNER. TO RESOLVE THE AMBIGUITY I MADE REFERENCE TO COUNTY SURVEY NO. 48. THAT SURVEY WAS A SUBDIVISION OF SAID NORTH HALF BY P.M. MORSE. THE DESCRIPTION OF DEED BOOK 2, PAGE 595 AS WELL AS OTHERS REFERENCED ON THE MAP WERE WRITTEN BASED ON THE MORSE SURVEY. MORSE MEASURED 30 CHAINS EAST FROM THE C-S 1/16TH CORNER TO ESTABLISH THE SOUTHEAST CORNER IN QUESTION. I ESTABLISHED SAID CORNER AS PER THE MORSE SURVEY.
