

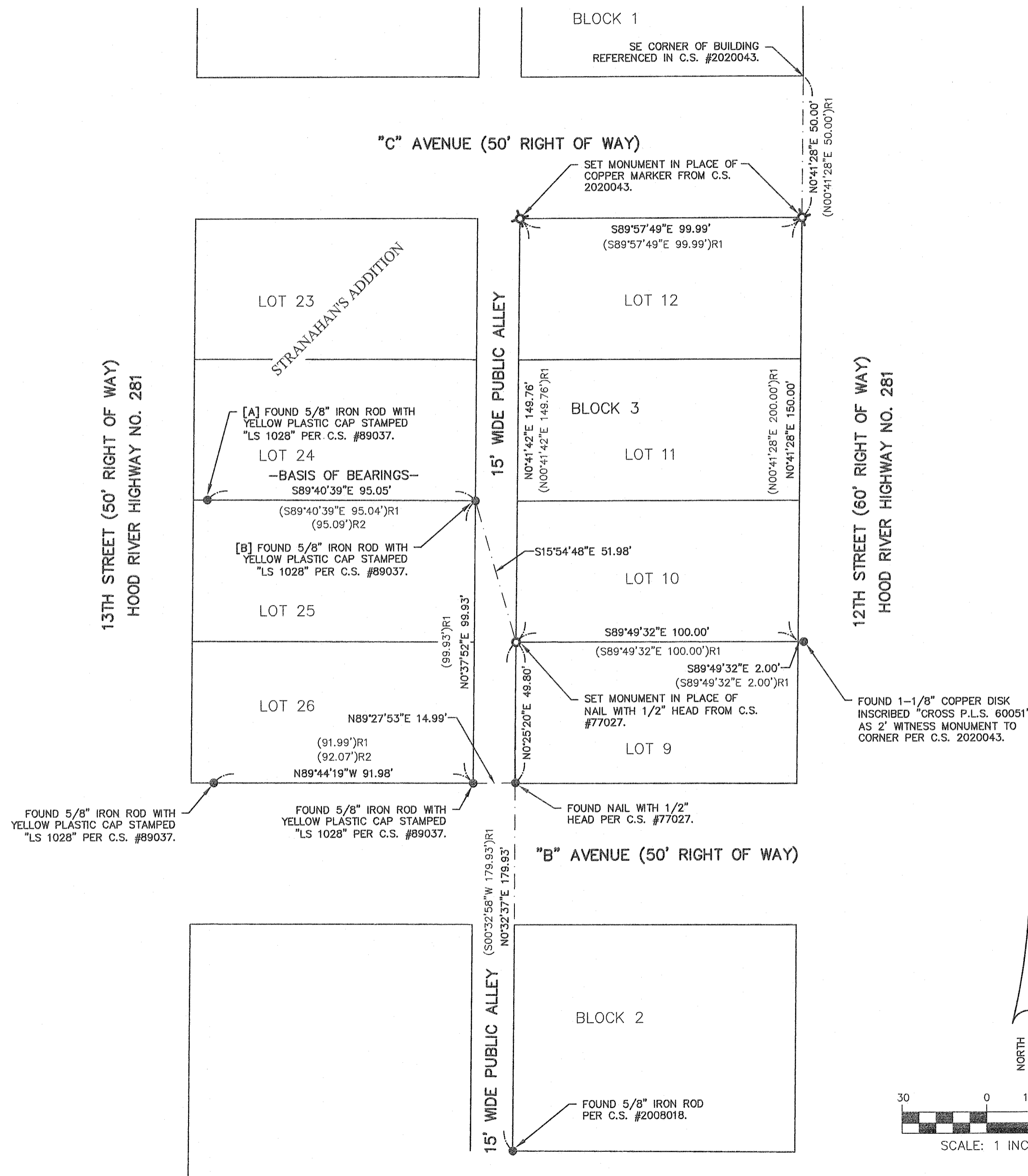

NARRATIVE:

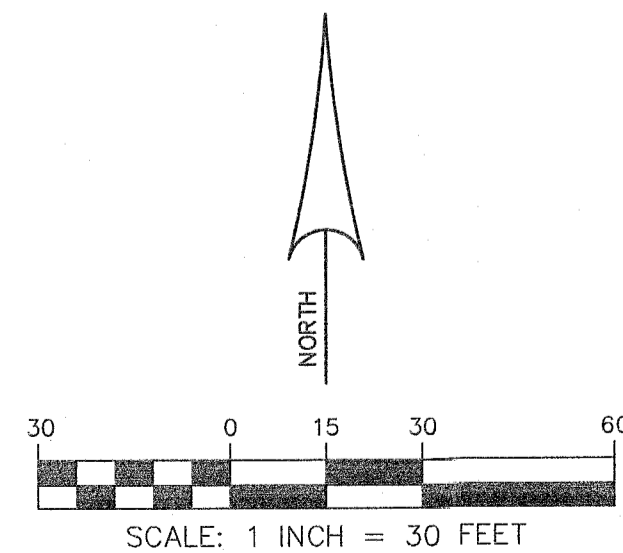

THE BASIS OF BEARINGS FOR THIS SURVEY WAS ESTABLISHED BY HOLDING SOUTH 89°40'39" EAST BETWEEN FOUND MONUMENTS [A] AND [B] PER C.S. #2020043. THE DESTROYED MONUMENTS WERE REPLACED IN THEIR ORIGINAL LOCATION AS SHOWN.
