
PROPERTY LINE ADJUSTMENT

THE PURPOSE OF THIS SURVEY IS TO SHOW AND ESTABLISH THE LOCATIONS OF PROPERTY CORNER MONUMENTS WHICH ARE BEING SET AS PART OF HOOD RIVER COUNTY PROPERTY LINE ADJUSTMENT PLANNING NUMBER #22-0121 BETWEEN TAX LOTS NUMBERS 2100 AND 2204, OF 1N-10E-19.

SAID LOTS ARE DESCRIBED IN WARRANTY DEED, INSTRUMENT NO. 2022-00762 (TAX LOT 2100) AND WARRANTY DEED, INSTRUMENT NO. 771029 (TAX LOT 2204)

THE PORTION OF TAX LOT 2100 BEING ADJUSTED IS DESCRIBED IN QUIT CLAIM INSTRUMENT NO. 2022-02763,

THE NORTH LINE OF TAX LOT 2100 IS DESCRIBED AS BEING 550 FEET SOUTH OF AND PARALLEL WITH THE NORTH LINE OF SECTION 19. THE SOUTH LINE OF TAX LOT 2100 IS DESCRIBED AS BEING 175.00 FEET SOUTH OF AND PARALLEL WITH THE NORTH LINE OF SAID TAX LOT 2100.

THE NORTH LINE OF TAX LOT 2204 IS DESCRIBED AS BEING 725 FEET SOUTH OF AND PARALLEL WITH THE NORTH LINE OF SAID SECTION 19. THE SOUTH LINE OF TAX LOT 2204 IS DESCRIBED AS BEING SOUTH 6*14' EAST ALONG THE CENTERLINE OF HIGHWAY NO. 281, A DISTANCE OF 54.5 FEET THENCE NORTHWESTERLY PARALLEL WITH THE NORTH LINE OF SECTION 19. SAID 54.5 FEET SOUTH ALONG THE CENTERLINE WAS HELD AND USED TO COMPUTE THE SOUTH LINE AS SHOWN.

FOR THIS SURVEY THE NORTH 1/4 CORNER OF SECTION 19 AND THE EAST 1/16 CORNER COMMON TO SECTION 18-19 WERE FOUND AND HELD TO COMPUTE THE 550 FOOT OFFSET AND THE 725 FOOT OFFSET FROM THE SECTION LINE.


MONUMENT NUMBER 255 WAS FOUND AS ESTABLISHED IN SURVEY NO. 7260 SAID MONUMENT FALLS 0.54' NORTH OF THE 550.00 FOOT OFFSET LINE. MONUMENT NUMBERS 253-254 WERE FOUND PER SURVEY NO. 7528. SAID MONUMENTS WERE NOT ACCEPTED BECAUSE THEY WERE FOUND TO BE 727.78 AND 727.66 SOUTH OF THE SECTION LINE.

THE WEST BOUNDARY IS THE EAST BANK OF THE CREEK WHICH WAS TIED AND IS SHOWN ON THIS SURVEY. REFERENCE MONUMENTS WERE SET NEAR THE EAST BANK OF THE CREEK AS SHOWN ON THE FACE OF THIS PLAT.

THE EAST BOUNDARY IS THE WEST RIGHT OF WAY OF HIGHWAY 281, THE CENTERLINE WAS TIED AND A 30 FOOT OFFSET WAS USED TO DETERMINE THE RIGHT OF WAY.


