

A 1/2" IRON PIPE WAS FOUND AND HELD FOR THE THE NORTHEAST CORNER OF THE SUBJECT LOT. SAID IRON PIPÉ WAS ALSO HELD IN COUNTY SURVEY NUMBERS 2022011, 1995119 AND 1977116. THE NORTH LINE OF THE SUBJECT LOT WAS ESTABLISHED BY HOLDING THE LINE BETWEEN SAID PIPE AND A 5/8" IRON ROD SET AT THE NORTHEAST CORNER OF BLOCK 1 OF E.B. CLARK'S FIRST ADDITION BY KLEIN AND ASSOCIATES IN COUNTY SURVEY NUMBER 2007015. THE NORTHWEST CORNER OF THE SUBJECT LOT WAS PLACED ON THIS LINE AT THE RECORD RIGHT OF WAY WIDTH OF 60 FEET EASTERLY OF SAID MONUMENT.
