

NARRATIVE:

THE PURPOSE OF THIS SURVEY WAS TO DEFINE THE PROPERTY BOUNDARY OF TAX LOT 900 AS DESCRIBED ON INST No.2021—05013. THE DEED DESCRIBES THIS PROPERTY AS THE SOUTH 100 FEET OF LOT 4 OF BLOCK 1 OF THE PARKHURST SUBDIVISION, EXCEPTING THE WEST 40 FEET. THE DEED ELEMENTS USED TO DETERMINE THIS BOUNDARY WERE MONUMENTS RECOVERED DEFINING LOT 3 AND LOT 4 IN BLOCK 1 OF PARKHURST ADDITION TO THE CITY OF HOOD RIVER. TAX LOT 900 WAS SURVEYED IN 1985 (C.S. 85046) BY GAYLORD L.S. 1815, WE RECOVERED AND HELD 5/8" IRON RODS L.S.1815 MONUMENTS AT THE NORTHWEST, SOUTHWEST AND SOUTHEAST. THE NORTHEAST CORNER WE RECOVERED A 1/2" IRON PIPE, TO BE 1.51 FEET WEST OF SAID CORNER PER C.S. 85046, THIS MONUMENT WAS HELD FOR THE NORTH LINE OF THE PROPERTY, WE ALSO HELD THIS DISTANCE TO SET TRUE CORNER. WE SET A IRON ROD AT THE TRUE CORNER TO AVOID CONFUSION AS TO THE TRUE CORNER LOCATION. HOLDING THE RECOVERED MONUMENTS FOUND ON THE SOUTH BLOCK LINE MEASURED SLIGHTLY LONGER FOR THE ORIGINAL PLAT DISTANCE. THIS RESOLUTION ALSO GIVES A SLIGHTLY LARGER RIGHT OF WAY OF 4TH STREET. THE BASIS OF BEARING FOR THIS SURVEY IS TWO 5/8" IRON RODS, L.S. 1815 ON THE SOUTH LINE OF TAX LOT 900.
