


THE PURPOSE OF THIS SURVEY IS TO MONUMENT A LAND CONVEYANCE AS DESCRIBED IN PRELIMINARY CONVEYANCE OF ACCESS RIGHTS AND WARRANTY DEED, ODOT FILE NO. 9464003, DRAWING RW9464M, BEING A PORTION OF TAX LOT 100 OF HOOD RIVER COUNTY ASSESSOR MAP 3N10E26CC. THE SUBJECT TRACT IS DESCRIBED IN BARGAIN AND SALE DEED, RECORDED SEPTEMBER 13, 2022. INSTRUMENT NO. 2022-02699. THE SUBJECT DEED DOES NOT AGREE WITH PAST SURVEYS PERFORMED ON AND AROUND THE SUBJECT TRACT. THE SUBJECT DEED CALLS FOR CARDINAL DIRECTION WITH MORE OR LESS, DISTANCES TO THE SOUTH RIGHT-OF-WAY OF CASCADE AVENUE THE WESTERLY RIGHT-OF-WAY OF RAND ROAD AND THE SOUTH LINE WHICH IS BOUND BY THE NORTH LINE OF THE HOWARD D. BUCHANAN TRACT, RECORDED IN INSTRUMENT NO. 880548. DUE TO THE CONFLICTING DEED ELEMENTS AND DISTANCES THE SUBJECT TRACT WAS ESTABLISHED AS FOLLOWS:

EXISTING SURVEY CONTROL AND MONUMENTS AS SHOWN ON HIGHWAY 30 AND RAND ROAD MONUMENT RECOVERY AND CONTROL SURVEY, FILED AS COUNTY SURVEY NO. 2022-073 WERE LOCATED AND HELD TO ESTABLISH THE BASIS OF BEARING, ALONG WITH THE ROAD ALIGNMENT AND RIGHT-OF-WAYS FOR CASCADE AVENUE (US HIGHWAY 30) AND RAND ROAD. A MATHEMATICAL MODEL OF COUNTY SURVEY NO. 1991-011 WAS COMPUTED AND ORIENTATED TO EXISTING RECOVERED MONUMENTS. THE WESTERLY AND SOUTHERLY BOUNDARY LINES WERE ESTABLISHED BASED ON THE COMPUTED POSITION PER COUNTY SURVEY NO. 1991-011, AS BEST AVAILABLE EVIDENCE TO THE BOUNDARY.,
