

#### NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO MONUMENT THE ADJUSTED LINES AND TO FILE FOR RECORD A PROPERTY LINE ADJUSTMENT BETWEEN PARCEL 3 OF THOSE TRACTS DESCRIBED IN DEED RECORDED AS INSTRUMENT NO. 2008-04666 (TAX LOTS 400/500) WITH THAT TRACT DESCRIBED IN DOC# 20063192 (TAX LOT 600). THE WEST LINE OF PARCEL 3 IS DESCRIBED AS THE CENTER OF AN IRRIGATION DITCH. THE CALL FOR THE DITCH CAN BE TRACED TO SEVERINA JOHANNSEN'S SUBDIVISION OF HER PROPERTY LOCATED IN THE NORTHEAST QUARTER OF SECTION 7 DURING THE 1920'S AND 1930'S. SOME OF THE DEED DESCRIPTIONS FOR SAID SUBDIVISION DESCRIBE THE DITCH AS MEASURED WEST FROM THE EAST SECTION LINE. WHEREAS OTHERS DESCRIBE THE DITCH AS MEASURED EAST FROM THE WEST LINE OF THE QUARTER SECTION. THERE IS CURRENTLY NO SURFACE EVIDENCE OF THE LOCATION OF THE DITCH THROUGHOUT THE QUARTER SECTION. I DID FIND TWO ABANDONED CONCRETE IRRIGATION BOXES AS DEPICTED ON THE MAP. I DETERMINED THAT MY OPTIONS FOR ESTABLISHING THE WEST LINE OF BOTH TRACTS WOULD BE ATTEMPTING TO USE THE LOCATION OF THE IRRIGATION BOXES OR MEASURING EAST OR WEST THE DEED DISTANCE FROM THE QUARTER SECTION LINES. MIDDLE FORK IRRIGATION DISTRICT INDICATED THAT THE BOXES ARE ASSOCIATED WITH A PIPE LINE THAT REPLACED THE DITCH. THE BOXES MIGHT SUGGEST AN APPROXIMATE LOCATION FOR THE OLD DITCH BUT WOULD NOT BE DEFINITIVE. CS 2003052 ADDRESSED THIS UNCERTAINTY BY MEASURING EAST FROM THE WEST QUARTER SECTION LINE THE DEED DISTANCE OF 950 FEET. I WILL DO THE SAME TO ESTABLISH THE WEST TRACT LINES. THE DEED DESCRIPTION OF TAX LOT 700 MAKES NO MENTION OF THE DITCH BUT ALSO DEFINES IT'S EAST LINE AS 950 FEET EAST OF THE QUARTER SECTION LINE. TO ESTABLISH THE BOUNDARIES OF TAX LOT 600, I HELD THE DEED CALLS AS MEASURED FROM IT'S WEST LINE. I RECOVERED CS 2003052 MONUMENTS AT THE SOUTHEAST AND SOUTHWEST CORNERS OF TAX LOTS 400/500. I ESTABLISHED THE NORTHEAST CORNER AT DEED DISTANCE WEST OF THE NORTHEAST SECTION CORNER. THE ADJUSTED LINES WERE ESTABLISHED AS PER CLIENT INSTRUCTION.
