

#### NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO MONUMENT THE COMMON PROPERTY LINE FOR A PROPERTY LINE ADJUSTMENT BETWEEN TAX LOT 201 AND TAX LOT 300, AS DESCRIBED IN PROPERTY LINE STATUTORY QUITCLAIM DEED INSTRUMENT NO. 2023-02408 AND STATUTORY QUITCLAIM DEED INSTRUMENT NO. 2023-02409.

THE EXTERIOR BOUNDARY OF TAX LOT 300 WAS WAS ESTABLISHED BY HOLDING THE NORTHEAST CORNER OF SECTION 33 AND THE EAST QUARTER CORNER OF SECTION 33. THEN USING THE DEED DISTANCES PER WARRANTY DEED, INSTRUMENT NO. 20040104.

THE DEED DISTANCE ARE DESCRIBED ALONG THE EAST LINE OF SECTION 33. THERE IS AN ORIGINAL ROAD RIGHT OF WAY WHICH WAS ORIGINALLY 40 FEET IN WIDTH LOCATED 20 FEET ON EACH SIDE OF THE SECTION LINE. SAID ROAD RIGHT-OF-WAY STILL EXISTS IN THIS AREA AND IS THE EASTERLY 20.00 FEET OF TAX LOT 300 AND TAX LOT 201

THE EXTERIOR BOUNDARY OF TAX LOT 201 WAS NOT SURVEYED OR MONUMENTED DURING THIS SURVEY. IT IS COMPUTED USING RECORD DATA.

NEW MONUMENTS WERE THEN SET ON THE ADJUSTED PROPERTY LINE AT CLIENTS REQUEST.


