

NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO LOCATE AND MONUMENT THE PROPERTY CONVEYED TO KEITH D. GREEN BY BARGAIN AND SALE DEED 2022-03483, RECORDED DECEMBER 21, 2022, HOOD RIVER COUNTY DEED RECORDS.

MONUMENTS OF RECORD WERE FOUND CORRELATING TO THE DEED LOCATION ALONG THE NORTHERLY LINE AS SHOWN. FOR THE SOUTHERLY LINE I HELD THE MONUMENTS FOUND FROM C.S.#2000108 AND HELD THE DEED DISTANCES SHOWN TO ESTABLISH THE SOUTHWEST CORNER AND SOUTHERLY SOUTHEAST CORNER. THE MISSING INTERIOR CORNER WAS SET AT THE DEED DISTANCE NORTH OF THE SOUTHERLY SOUTHEAST CORNER HOLDING THE DIRECTION FOR THE WEST LINE AS PER THE DEED. FOR THE EASTERLY LINE ALONG THE HIGHWAY I HELD THE MONUMENTS FOUND CORRELATING TO THE DEED AS PER C.S.#2000071. THE LINES RUNNING WESTERLY FROM THE EAST LINE WERE HELD PARALLEL TO THE SOUTHERLY LINE AS PER THE

THE SUBJECT DEED DESCRIBES A PRIVATE WATER LINE EASEMENT THAT IS NOT LOCATED OR SHOWN ON THIS SURVEY.

TRILLIUM ROAD IS SHOWN AS PER THE PRIVATE 50 FOOT WIDE EASEMENT FOR ROAD AND UTILITIES DESCRIBED BY JOINT USE AND MAINTENANCE AGREEMENT DEED 84-1816. OTHER EASEMENTS THAT A CURRENT TITLE REPORT WOULD DISCLOSE MAY EXIST THAT ARE NOT SHOWN.
