
# RECORD OF SURVEY

### NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO LOCATE THE EXTERIOR BOUNDARY AND BUILDING IMPROVEMENTS ON TAX LOT 7300 OF HOOD RIVER COUNTY ASSESSOR MAP 03N10E36AB, BEING DESCRIBED IN STATUTORY WARRANTY DEED, RECORDED OCT. 30, 2023, INSTRUMENT NO. 2023-02167, HOOD RIVER COUNTY DEED RECORDS. THE PROPERTY IS DESCRIBED AS THE NORTH 100 FEET OF LOT 3, BLOCK 5, WINAN'S ADDITION.

THE EXTERIOR BOUNDARY OF BLOCK 5, WINAN'S ADDITION, WAS PREVIOUSLY ESTABLISHED BY TENNESON ENGINEERING CORP., FILED AS COUNTY SURVEY 1181. TWO 5/8" IRON ROD WERE FOUND AND HELD, ONE LOCATED AT THE SOUTHEAST CORNER AND THE OTHER AT THE NORTHWEST CORNER OF SAID BLOCK 5. A 5/8" REBAR, SET BY BISHOP SURVEYING, FILED AS COUNTY SURVEY NO. 78104, FOR A REFERENCE MONUMENT TO THE NORTHEAST CORNER OF SAID BLOCK 5, WAS FOUND AND HELD FOR A POINT ON THE EASTERLY EXTENSION OF THE NORTH LINE OF SAID BLOCK 5. SAID BISHOP SURVEY SHOWS A REFERENCE MONUMENT WAS SET 4.00 FOOT EAST OF THE NORTHEAST CORNER OF BLOCK 5, THIS SURVEY FOUND SAID BISHOP MONUMENT TO BE 3-FOOT EAST ONLINE. ANOTHER RECOVERED BISHOP MONUMENT ALONG THE WEST RIGHT-OF-WAY OF E. 4TH STREET, POINT (251) WAS ALSO FOUND TO BE OFF.. TWO 1/2" IRON RODS AS SHOWN IN COUNTY SURVEY 2005063, ALONG THE WEST LINE OF THE SUBJECT TRACT WERE RECOVERED, AND FOUND TO BE WITHIN ACCEPTABLE TOLERANCES AND HELD IN THIS SURVEY. A PK NAIL OF UNKNOWN ORIGIN FOUND AT THE NORTHEAST CORNER OF THE SUBJECT TRACT AND WAS ACCEPTED IN THIS SURVEY. NEW PROPERTY MONUMENTS WERE THEN SET AT THE SOUTHEAST, SOUTHWEST, AND NORTHWEST CORNER AS SHOWN.
