


NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO MONUMENT THE COMMON PROPERTY LINE FOR A PROPERTY LINE ADJUSTMENT BETWEEN TAX LOT 6000, DESCRIBED AS PARCEL 1 OF PARTITION PLAT 201724P AND TAX LOT 6003, BEING DESCRIBED IN THREE SEPARATE WARRANTY DEEDS, INSTRUMENT NO. 700690, 700689, AND 700688. A PROPERTY LINE ADJUSTMENT DEED WAS PREPARED BY OUR CLIENT AND IS RECORDED IN PROPERTY LINE ADJUSTMENT DEED, INSTRUMENT NO. 2024—00638. THE EXTERIOR BOUNDARY OF TAX LOT 6000, BEING PARCEL 1 OF PARTITION PLAT 201724P, WAS PREVIOUSLY ESTABLISHED BY TERRA SURVEYING. TAX LOT 6003 WAS ESTABLISHED IN A PREVIOUS SURVEY PERFORMED BY OUR FIRM, AND FILED AS COUNTY SURVEY NO. 96060. 
