## NARRATIVE

PURPOSE OF THE SURVEY:

THIS SURVEY MONUMENTS A PERMANET EASEMENT FOR HIGHWAY RIGHT-OF-WAY PURPOSES THAT WAS ACQUIRED BY THE OREGON DEPARMENT OF TRANSPORTATION (ODOT) IN DOCUMNET NUMBER 2024-00817, FOR THE CONSTRUCTION OF THE ODOT PROJECT I-84 RUCKEL CREEK CULVERT. THIS SURVEY IS LOCATED ON THE COLUMBIA RIVER HIGHWAY I-84 AT RUCKEL CREEK AND ENCOMPASSES A PORTION OF THE COLUMBIA RIVER HIGHWAY FROM MP 42.1 TO 42.3. NO MONUMENTS WERE DESTROYED BY CONSTRUCTION FOR THIS PROJECT. PROPERTY BOUNDARIES HAVE NOT BEEN RESOLVED IN THIS SURVEY BUT ARE SHOWN PER DEED OR OTHER AVAILABLE REFERENCE DATA.

#### PROJECT CONTROL:

COORDINATES SHOWN ARE OREGON COORDINATE REFERENCE SYSTEM (OCRS) - COLUMBIA RIVER WEST. OCRS ZONE PROJECTION PARAMETERS ARE REFERENCED IN OAR 734-005-0015. HORIZONTAL DATUM IS NAD 83 (2011) EPOCH 2010.00. ALL LINEAR VALUES ARE EXPRESSED IN INTERNATIONAL FEET. GRID DISTANCES CLOSELY MATCH GROUND DISTANCES.

THIS SURVEY UTILIZES CONTROL THAT WAS SET IN HOOD RIVER COUNTY SURVEY 2023-010. ALL NETWORK POINTS WERE RECOVERED IN GOOD CONDITION. NO ADDITIONAL NETWORK POINTS WERE ESTABLISHED DURING THIS SURVEY.

#### MONUMENT OBSERVATION NOTES:

A SEARCH FOR ALL SURVEY MONUMENTS WAS MADE WITHIN THE PROJECT LIMITS. HORIZONTAL POSITIONS FOR THE FOUND MONUMENTS WERE OBTAINED USING A COMBINATION OF RTK GPS MEASUREMENTS UTILIZING CORRECTION DATA PRODUCED BY THE ORGN, AND TERRESTRIAL MEASUREMENTS HOLDING THE CONTROL NETWORK ADJUSTED COORDINATES.

THE MONUMENTS WERE SET BY RADIAL COORDINATE STAKEOUT FROM THE CONTROL NETWORK.

ALIGNMENT RECOVERY AND RIGHT OF WAY LINES:

THIS SURVEY USES THE ALIGNMENT OF THE COLUMBIA RIVER HIGHWAY I-84 AND THE RIGHT OF WAY LINES ESTABLISHED IN HOOD RIVER COUNTY SURVEY 2023-010.




